part of a farm to another part of the same farm being in the same occupation, provided that the animal to be moved is not afficted with Foot-and-Mouth Disease, and that the animal is not in a Foot-and-Mouth Disease Infected Place, or Foot-and-Mouth Disease Infected Area, and that the movement of such animal is not prohibited by Notice of an Inspector of a Local Authority or of the Board of Agriculture given under any Order of the Board.
