No. 68.—BALTIC—THE SOUND ENTRANCE.

Kullen Light—Intended Alteration in Character.

THE Swedish Government has given notice that it is intended, about August, 1900, to alter the character of Kullen Light from revolving every two minutes to flashing every five seconds.

Approximate position, lat. 56° 18' N., long. 12° 27' E.

Barseback Point Light—Intended Alteration in Character.

Krishna Light-Vessel—Temporarily Replaced.

THE Government of India has given notice, that during the first week of February, 1900, Krishna Light-vessel (group-flashing white light) would be temporarily withdrawn, and replaced by the light-vessel "Martaban," which shows a flashing white light every forty-five seconds, thus:—light, five seconds; eclipse, forty seconds.
