NORFOLK AND SUFFOLK SALES AND MOVE-MENT (FOOT-AND-MOUTH DISEASE) ORDER OF 1900 (No. 2).

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Alteration of Boundaries of Scheduled District.

1.-(1.) The Scheduled District for the purposes of the Norfolk and Suffolk Sales and Movement (Foot-and-Mouth Disease) Order of 1900 shall after the commencement of this Order be the District described in the First Schedule to this Order.

(2.) Part II. of such Order shall after the commencement of this Order apply to that part of the Scheduled District which is described in the Second Schedule to this Order.

Movement within Part of Scheduled District for breeding purposes.

2.-(1.) An animal (not being in a Foot-and-Mouth Disease Infected Place or Area) may be moved for breeding purposes from any premises in that part of the Scheduled District which is described in the Second Schedule to this Order to any other premises in such part of the Scheduled District with a Licence under Article 6 of the above-mentioned Order, provided that the premises to which the animal is to be moved are not in a Foot-and-Mouth Disease Infected Place or Area, and that the Licence is expressly stated to be for movement for breeding purposes.

(2.) A Licence so granted for movement for breeding purposes shall be available for the movement of the animal back to the premises from which it was moved under the Licence, provided that such movement takes place within the four days during which such Licence is available.

Commencement.

3. This Order shall come into operation on the fifth day of March, one thousand nine hundred.

Short Title.

4. This Order shall be read with the Norfolk and Suffolk Sales and Movement (Foot-and-Mouth Disease) Order of 1900, and may be cited as the NORFOLK AND SUFFOLK SALES AND MOVE-MENT (FOOT-AND-MOUTH DISEASE) ORDER OF 1900 (No. 2).

BEDFORDSHIRE AND HERTFORDSHIRE SALES AND MOVEMENT (FOOT - AND - MOUTH DISEASE) ORDER OF 1900 (No. 2).

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Movement within Scheduled District for purposes other than Slaughter.

1.-(1.) An animal may be moved from any premises in the Scheduled District (not being in a Foot-and-Mouth Disease Infected Place or Area) to any other premises within such District for purposes of breeding, feeding, isolation, or lambing, provided that the animal is accompanied by a Movement Licence as required by this Article.

(2.) The Licence shall only be granted on a Declaration of the owner of the animal or of his agent authorized in writing for this purpose to the effect :

(i.) that the animal to be moved has been on the premises from which it is to be moved
