Martyr Bordesley in the county of Warwick and in the diocese of Worcester.

"Whereas at certain extremities of the said new parish of Saint Alban the Martyr Bordesley, of the new parish (sometime district chapelry) of Balsall Heath in the said county and diocese and of the new parish (sometime district chapelry) of Saint Thomas-in-the-Moors Balsall Heath in the same county and diocese which said extremities lie contiguous one to another, and are described in the Schedule hereunder written there is collected together a population which is situate at a distance from the several churches of such new parishes respectively.

" And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said new parish of Saint Alban the Martyr Bordesley of the said new parish of Balsall Heath and of the said new parish of Saint Thomas-in-the-Moors Balsall Heath, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Patrick Bordesley situate as aforesaid.

"Now therefore, with the consent of the Right Reverend John James Stewart Bishop of the said diocese of Worcester as such Bishop (in testimony whereof he has sealed this representation and caused his episcopal seal to be affixed hereto) and with the consents of the Reverend Walter Lock, Clerk in Holy Orders, Doctor in Divinity, Warden of Keble College in the University of Oxford, of the Right Reverend Edward, Bishop of Lincoln, of the Right Honourable Henry Hucks Baron Aldenham, of John Archibald Shaw-Stewart of Number 48 Chester-square London Esquire, and of the Reverend William Bright Clerk in Holy Orders Doctor in Divinity Canon of the Cathedral Church of Christ in Oxford, as the patrons of the vicarage of the said new parish of Saint Alban the Martyr Bordesley and with the consent of the Reverend Charles William Barnard Clerk in Holy Orders, Vicar of the parish of King's Norton in the said county of Warwick, and, as such Vicar the patron of the vicarage of the new parish of Balsall Heath aforesaid, and with the consents of John Dent Goodman of Peachfield Edgbaston in the city of Birmingham Esquire of Frederick Buck Goodman, of Farquhar-road, Edgbaston aforesaid Esquire, of Francis Cleland Bourne of Kempsey in the county of Worcester Gentleman of Howard Lloyd of Cannon Hill House, near the city of Birmingham aforesaid, Banker, and of the Reverend Cecil Walker Cox of Church-street, Warwick in the said county of Warwick, Clerk in Holy Orders, as the patrons of the vicarage of the new parish of Saint Thomas-in-the-Moors Balsall Heath aforesaid (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Saint Alban the Martyr Bordesley, of the said new parish of Balsall Heath, and of the new parish of Saint Thomas-in-the-Moors Balsall Heath afore aid which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Patrick Bordesley situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Patrick Bordesley.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Patrick

Bordesley comprising :-

" I. All that portion of the new parish (sometime district) of Saint Alban the Martyr Bordesley, in the county of Warwick, and in the diocese of Worcester, which is bounded upon the west by the parish of Edgbaston, in the said county and diocese, upon the south-west by the hereinafter described portion of the new parish (sometime district chapelry) of Balsall Heath in the county of Worcester and in the said diocese of Worcester upon the east by the new parish of the Holy Trinity Bordesley, in the said county of Warwick and in the diocese of Worcester aforesaid, and upon the remaining side that is to say, upon the north-east by an imaginary line commencing upon the boundary which divides the said new parish of the Holy Trinity Bordesley from the new parish of Saint Alban the Martyr Bordesley aforesaid, at the point in the middle of Moseley-road opposite to the eastern end of the wall or fence which divides the house and premises numbered 275, Moseleyroad, from the house and premises numbered 273, Moseley-road and extending thence first westward and then generally north-westward to and along the said wall or fence and along the wall or fence at the backs of the houses and premises numbered 219, 217 and 215, Conybere street for a distance of three and a half chains or thereabouts to the junction of the last described wall or fence with the wall or fence forming the boundary of the house and premises numbered 213 Conybere-street, and extending thence first north-westward, then south-westward and then again north-westward along the last-mentioned wall or fence for a distance of one and a half chains or thereabouts to its junction with the wall or fence forming the south-western boundary of the house and premises numbered 211 Conybere-street and extending thence north-westward along the last-mentioned wall or fence and along the wall or fence dividing the houses and premises situate on the north-eastern side of Stoke-square from the houses and premises situate on the south-western side of Conyberestreet aforesaid and along the wall or fence dividing the house and premises numbered 14 Hick-street from the house and premises numbered 15 Hick-street for a distance of two and a quarter chains or thereabouts to the north-western end of the last-mentioned wall or fence upon the southeastern side of Hick-street aforesaid and extending thence first north-westward to and then southwestward along the middle of the last-named street for a distance of one and a half chains or thereabouts to the point opposite to the southeastern end of the wall or fence which divides the house and premises numbered 25 Hick-street from the passage forming the north side of Wallis'splace and extending thence north-westward to and along the last-mentioned wall or fence for a distance of two and a half chains or thereabouts to the western corner of the last-mentioned house and premises at the south-eastern end of the wall or fence which divides the passage situate on the north-eastern side of Saint Albans-place from the house and premises situate on the south-western side of the passage or court called Imperialbuildings and extending thence north-westward along the last-mentioned wall or fence and along the wall or fence which divides the house and
