east by the parish of Plumstead aforesaid upon the south and south-west by the new parish of Christ Church Shooter's Hill aforesaid, upon the west by the parish of Woolwich aforesaid, and upon the remaining sides, that is to sav, upon the north and upon the east by an imaginary line commencing upon the boundary which divides the said parish of Woolwich from the new parish of All Saints Shooter's Hill Plumstead aforesaid at the parish boundary stone upon the eastern side of Red Lion-lane distant eight chains or thereabouts to the south of the junction of the same lane with Herbert-road and extending thence in a direction due east and in a straight line for a distance of twenty-eight chains or thereabouts to a point in the middle of the northern end of the private roadway leading from Eglinton-road along the backs of the houses and premises on the western side of Shrewsbury-lane into the lastnamed lane and extending thence first south-westward and then south-eastward along the middle of the same private roadway for a distance of eighteen chains or thereabouts to its junction on the northern side of the house and premises known as the Homestead with Shrewsbury-lane aforesaid upon the boundary which divides the said new parish of All Saints Shooter's Hill Plumstead from the parish of Plumstead aforesaid."

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively signified their assent

And whereas the said scheme or representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her Majesty, chapter thirty-nine and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her Majesty chapter one hundred and thirteen, the Act of the fourth and fifth years of Her Majesty chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her Majesty chapter one hundred and fourteen duly prepared and laid before Her Majesty in Council a scheme bearing date the twenty-fifth day of January, in the year one thousand nine hundred in the words following, that is to say :-

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the thirtythird and thirty-fourth years of Your Majesty chapter thirty-nine, and of the Acts therein mentioned that is to say, the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen, the Act of the fourth and fifth years

Act of the thirty-first and thirty-second years of Your Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Beighton, in the county of Derby and in the diocese of Southwell.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Beighton is vested in the Right Honourable Charles William Sydney, Earl Manvers as tenant for life free from incumbrances under the following deeds namely an indenture dated the twentyfirst day of June in the year one thousand eight hundred and seventy-six and made between the Right Honourable Sydney William Herbert Earl Manvers since deceased and the said Charles William Sydney now Earl Manvers of the first part Thomas Bradshaw and the Reverend Henry Seymour of the second part and the Reverend Evelyn Hardolph Harcourt Vernon and Henry Sydney Seymour of the third part and two deeds poll dated respectively the eighth day of May in the year one thousand eight hundred and ninety-nine and the thirteenth day of July in the year one thousand eight hundred and ninety-nine both under the hands and seals of the said Sydney William Herbert Earl Manvers since deceased and Charles William Sydney now Earl Manvers,

"And whereas the said Charles William Sydney Earl Manvers is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Beighton now vested in him as aforesaid should be transferred to and be vested in the Bishop for the time being of the said diocese of Southwell.

"And whereas the Right Reverend George now Bishop of the said diocese of Southwell is willing to accept such transfer and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he the said George Bishop of the said diocese of Southwell has executed this scheme as hereinafter mentioned.

"And whereas the transfer of the patronage of the said benefice of Beighton which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists that is to say in the parish of Beighton.

"Now therefore with the consent of the said Charles William Sydney Earl Manvers (in testimony whereof he has signed and sealed this scheme) and with the consent of the said George Bishop of the said diocese of Southwell (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal) we the said Ecclesiastical Commissioners for England humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Beighton now vested in him the said Charles William Sydney Earl Manvers as tenant for life under the said indenture dated the twentyfirst day of June in the year one thousand eight of Your Majesty, chapter thirty-nine, and the hundred and seventy-six and the said two deeds
