

a. A shoal extends from the western shore for $2\frac{1}{2}$ cables opposite and towards the south point of Ullapool, over which there is a depth of from 27 to 28 feet at low-water spring tides; the northern end of this shoal is situated with the south point of Ullapool bearing N. 1° E., distant $2\frac{1}{2}$ cables, and Ferry House N. 83° W.

Approximate position, lat. $57^{\circ} 52' 25''$ N., long. $5^{\circ} 9' 45''$ W.

This reduces the width of the navigable channel at low water, for large ships, off the south point of Ullapool to 2 cables.

b. A shoal, named Otter Bank, $1\frac{1}{2}$ cables in extent, which has a depth of 28 feet over it at low-water spring tides, the northern end of which is situated with the south point of Ullapool bearing N. 27° W., distant 6 cables, and Ferry House N. 67° W.
