In bringing the above Proclamation to your notice I would point out that, by virtue of the above-mentioned Proclamations of the 1st February, 1897, 27th June, 22nd August, 10th and 27th October, and 5th December, 1893, the following places shall, until further notice, be regarded as infected by the oriental plague:—Oporto (town of), Portugal; Mozambique, including Lorenzo Marques; Arabia; Persia; India; China; Formosa; Mauritius; Madagascar; Paraguay (port of).
