*Umatilla Light-Vessel Temporarily Withdrawn—
Gas Buoy Placed.*

THE United States Government has given notice, that on or about 15th May, 1900, Light-vessel No. 67, moored about $2\frac{1}{2}$ miles S.W. $\frac{3}{8}$ S. from Umatilla Reef, Flattery Rocks, off Cape Flava, and about $4\frac{1}{4}$ miles west-south-westerly from the Cape, will be temporarily withdrawn for repairs, and replaced by a gas-buoy showing a fixed white light.

The buoy is painted red with the words "light-vessel moorings" in black.

Light-vessel No. 67 will be returned to her station as soon as repairs have been completed, and the buoy withdrawn, of which due notice will be given.
