said six wards are hereinafter named and numbered as follows, that is to say:—
"1. Minster Ward.

- "2. Castle Ward.
- "3. Abbey Ward.
- "4. Carholme Ward.
- "5. Park Ward.
- "6. Witham Ward.

"No. 1. Minster Ward.

"I do hereby determine that Minster Ward shall comprise so much of the said city of Lincoln as is comprised within an imaginary line, commencing at a point in Newport where the city boundary crosses the same, thence southwards along the centre of Newport, Bailgate, Steep Hill, the Strait, and High-street, to the intersection of Butchery-street; thence eastwards, along the centre of Butchery-street, Clasketgate, Monks-road and Monks-lane to the extreme eastern boundary of the city, eastwards of Monks-lane stables, thence in a morth-westerly direction along the said city boundary to the point of commencement aforesaid;

> " No. 2. Castle Ward.

"I do hereby determine, that Castle Ward shall comprise so much of the said city of Lincoln, as is comprised within an imaginary line, commencing at a point in Newport, where the city boundary crosses the same, thence southward along the centre of Newport, Bailgate, Steep Hill, the Strait and High-street to the intersection of Corporationstreet, thence in a north-westerly direction along the centre of Corporation-street, West-parade, and Yarborough-road, to a point opposite the eastern boundary of the West Common, thence in a south-westerly direction along the said West Common boundary to the centre of the Foss Dyke Navigation, where it reaches the city boundary, thence in a westerly direction along the city boundary, in the centre of the Foss Dyke Navigation, to the extreme western boundary of the city, thence in a north-easterly direction along the said city boundary, to the point of commencement aforesaid.

"No. 3. Abbey Ward.

"I do hereby determine, that Abbey Ward shall comprise so much of the said city of Lincoln, as is comprised within an imaginary line commencing at a point at the intersection of High-street and Butchery-street, thence in a southerly direction along the centre of High-street to the centre of the Great Northern Railway Line, where it crosses High-street by a level crossing, thence in an easterly direction along the centre of the Great Northern Railway Line till it reaches the eastern boundary of the city, thence in a northerly direction, for a distance of seventy yards, following the city boundary aforesaid, thence in an easterly direction following the said city boundary to the extreme eastern boundary of the city, thence in a northerly direction following the said city boundary, till it reaches a point opposite the centre of Monkslane, thence in a westerly direction along the centre of Monks-lane, Monks-road, Clasketgate, and Butchery-street, to the point of commencement aforesaid.

"No. 4. Carholme Ward.

"I do hereby determine, that Carholme Ward shall comprise so much of the said city of Lincoln, as is comprised within an imaginary line commencing at a point in the centre of High-street at the intersection of High-street and Corporationstreet, thence in a north-westerly, and afterwards in a southerly direction along the southern boundary of Castle Ward as hereinbefore defined, to the centre of the Foss Dyke Navigation, thence in an easterly direction along the said city

boundary in the centre of the said Foss Dyke Navigation, to a point opposite the Chemical Works, thence in a southerly direction, following the city boundary, for a distance of eighty yards till it reaches the centre of the Great Northern Railway Line, thence in a south-easterly direction along the centre of the said Great Northern Railway Line till it reaches the centre of Highstreet, thence in a northerly direction along the centre of High-street to the point of commencement aforesaid.

"No. 5. Park Ward.

"I do hereby determine, that Park Ward shall comprise so much of the said city of Lincoln, as is comprised within an imaginary line commencing at a point in High-street at the centre of the Great Northern level crossing, thence in a southerly direction along the centre of High-street, Saint Catherine's and Cross O'Cliff-road, to a point opposite the hedge on the footpath at the top of South Common, thence in a northeasterly direction, following the line of the city boundary, which is four feet to the south of the aforesaid hedge, thence in a northerly direction along the eastern side of Canwick-road, thence in an easterly direction, still following the city boundary, along the southern hedge of Washingborough-road, thence in a northerly direction alongside the footpath immediately adjoining the eastern side of the Cemetery and the old boundary of the Cowpaddle till it reaches the Great Northern Railway Line, thence in a westerly direction along the said railway line to the point of commencement aforesaid.

" No. 6. Witham Ward.

"I do hereby determine, that Witham Ward shall comprise so much of the said city of Lincoln, as is comprised within an imaginary line commencing at a point in High-street at the centre of the Great Northern Railway level crossing, thence in a north-westerly direction along the centre of the said railway till it reaches the city boundary opposite the Chemical Works, mentioned in the description of the boundaries of Carholme Ward, thence following the city boundary in a southerly and south-easterly direction till the same reaches the centre of the River Witham, opposite the premises at the back of the Shakespeare Inn in High-street, thence continuing in a southerly direction, following the said city boundary, in the centre of the said River Witham, thence in an easterly direction following the said city boundary, to the centre of Cross O'Cliff-road, thence in a northerly direction along the centre of Cross O'Cliff-road, Saint Catherine's and High-street to the point of commencement aforesaid.

"And I do hereby apportion three Councillors to each and every of the said six wards as follows,

that is to say:-

"To No. 1.-Minster Ward. Councillors: Richard Ellis, Sharpley Bainbridge and Wilson Blaze.

" To No. 2.—Castle Ward. Councillors: Edward Harrison, Maurice Henry Footman, and Benjamin Vickers.

"To No. 3.—Abbey Ward. Councillors: Henry Alfred Cottingham, John William Ruddock, and John Thomas Collier.

"To No. 4.—Carholme Ward. Councillors: Charles Pratt, George Henry Beagle, and Thomas Harry White.

"To No. 5.—Park Ward. Councillors: Henry Barker Kirkby, Charles Waldegrave Pennell, and Thomas Wallis.

"To No. 6.-Witham Ward. Councillors: John Henry Foster, James Dixon Goy; and Samuel Horton.
