THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Representative at Trieste, enclosing the following Notice respecting quarantine, viz. :—

Translation of Circular No. 6088 of the Imperial and Royal Marine Board at Trieste to all Imperial and Royal Offices and Officers and Subordinate Port and Sanitary Offices and Officers.

The Imperial and Royal Ministry of Commerce in union with the Royal Hungarian Ministry of Commerce and with the Imperial and Royal Ministry of the Interior ordered (by despatch of May 8th, 1900, No. 1267 H.M., and also by successive telegrams of May 15th and 16th, 1900, Nos. 1418 H.M. and 1327 H.M.) that arrivals from all Egyptian ports, as well as from those ports of the Red Sea where the existence of plague has been ascertained, will have to be treated should the voyage last less than ten days in accordance with the sanitary measures issued by the Venice Sanitary Convention of 1897 (by Government circular of June 7th, 1899, No. 6462) against arrivals from Alexandria. It is naturally understood that instead of the prohibition of importation and transit of certain specified goods from Egypt mentioned in the above said circular, the regulations contained in circular of May 9th, 1900, No. 5740, will have to be followed.
