THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a translation of a Decree of the Imperial Governor of Samoa, by which the landing in the harbour of Apia of "gunny" bags (jute) or cloth bags, or of goods packed in such bags, which come from plague-stricken ports, is prohibited until further notice. The importation into Apia of fresh vegetables or fruit from plague-stricken ports is likewise forbidden until further notice. The Decree came into force on 24th April, 1900.
