eastern corner of the Saint Pancras Cemetery aforesaid at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London. ## PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter one hundred and four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-sixth day of July, in the year one thousand nine hundred, in the words following, that is to say: —

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and of the Act of the nineteenth and twentieth years of Your Majesty, chapter one hundred and four have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district or new parish for spiritual purposes partly out of the district of Saint Stephen, Bournemouth, partly out of the new parish (sometime district) of Saint John Moordown and partly out of the new parish (sometime district) of the Holy Trinity Bournemonth all in the county of Southampton and in the diocese of Winchester.

"Whereas it has been made to appear to us that it would promote the interests of religion that all those portions of the said district of Saint Stephen Bournemouth of the said new parish of Saint John Moordown and of the said new parish of the Holy Trinity Bournemouth which are hereinafter mentioned and described should be constituted a separate district or new parish for spiritual purposes in manner hereinafter set forth.

"And whereas we are satisfied that the said hereinbefore mentioned district and new parishes are cures wherein or in parts whereof the provision for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof.

"And whereas there is within the limits of the district or new parish so hereihafter recommended and proposed to be constituted as aforesaid a consecrated church in use for the purposes of Divine worship being the church of Saint Augustin of Hippo situate within the said district of Saint Stephen Bournemouth.

<sup>47</sup> And whereas the late Reverend Henry Twells of Thornleigh Bodorgan-road, Bournemouth in the said county of Southampton Clerk in Holy Orders and Honorary Canon of Peterborough has contributed and paid to the credit of our account at the Bank of England a capital sum of five thousand pounds sterling as and for the endowment of the district

or new parish herein proposed to be constituted and as and for the maintenance of the minister or incumbent thereof for the time being and we have in respect of such sum agreed with the said Henry Twells to pay by equal quarterly payments on the first day of February the first day of May the first day of August and the first day of November in each and every year to such minister or incumbent when duly licensed in accordance with the provisions of the hereinbefore firstly mentioned Act a sum of one hundred and fifty pounds per annum so long as the said capital sum shall remain in our hands.

"And whereas the said capital sum of five thousand pounds sterling has been so contributed and paid as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of patronage of the said proposed district or new parish and of the nomination of the minister or incumbent thereof should be assigned in the manner hereinafter recommended and proposed.

recommended and proposed. "And whereas the said late Henry Twells did nominate to us the Right Reverend Randall Thomas Bishop of the said diocese of Winchester as the person in whom and in whose successors Bishops of the same diocese for ever he the said Henry Twells was desirous that such right of patronage and nomination should be vested.

"Now therefore with the consent of the said Randall Thomas, Bishop of the said diocese of Winchester (in testimony whereof he has signed and sealed this scheme) we the said Ecclesiastical Commisioners for England humbly recommend and propose that all those portions of the said district of Saint Stephen Bournemouth, of the said new parish of Saint John Moordown and of the said new parish of the Holy Trinity Bournemouth which are described in the schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named (when such district shall have become as it will by operation of law at once become a new parish) 'The New Parish of Saint Augustin Bournemouth.

"And we further recommend and propose that the said church of Saint Augustin of Hippo being a consecrated church in use for the purposes of Divine worship and situate within the limits of the district or new parish hereinbefore recommended and proposed to be constituted shall as from the day last mentioned be and for that purpose we hereby specify the same church as the parish church of the said new parish of Saint Augustin, Bournemouth.

"And we further recommend and propose with the consent of the said Randall Thomas Bishop of the said diocese of Winchester (testified as aforesaid) that the whole advowson and perpetual right of patronage of the said proposed district or new parish, that is to say, of the new parish of Saint Augustin Bournemouth aforesaid and the right of nomination of the incumbent of the same new parish shall without any conveyance or assurance in the law other than this scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and as from the day aforesaid being the day of the date of the publication of such Order in the London Gazette be assigned to and become and be absolutely vested in and shall and may from time to time be exercised by the said Randall Thomas.
