Visiting Officer to coal in quarantine at the Rendezvous Buoy, in the Castries Harbour, from lighters with the assistance of labourers from the shore, but no such labourer or any other person shall be allowed to go on board such vessel, and such vessel shall not be coaled between sunset and sunrise, and every precaution shall be taken to prevent rats being conveyed from any such vessel to the shore.

4. The Regulations passed by the Governor-in-Council on the 15th day of December, 1899, are hereby repealed.
