#### DENBIGHSHIRE AND FLINTSHIRE (FOOT-AND-MOUTH DISEASE) ORDER OF 1900 (No. 3).

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

#### Movement within Petty Sessional Divisions of Rhuddlan and Prestatyn.

1. The provisions of the Denbighshire and Flintshire (Foot-and-Mouth Disease) Order of 1900 (No. 2) relating to movement of animals within the Scheduled District shall after the commencement of this Order apply to the petty sessional divisions of Rhuddlan and Prestatyn, provided that nothing in the said Order or this Order shall authorize the movement of any animal into or out of or along over or across a highway or thoroughfare within any Foot-and-Mouth Disease Infected Place or Area.

#### Commencement.

2. This Order shall come into operation on the tenth day of September, one thousand nine hundred.
