STATUTE III, 20, delete down to "and the," and substitute "The"; add after "time of elec-tion," "under clause 19 (a) and (b) hereof."

STATUTE III, 26, delete " not later than the : next ensuing stated day of election."

STATUTE III, 29, delete clause as it stands, and substitute-

"The Principal and Fellows may, if at any . time or times they consider that the corporate revenues are sufficient for the purpose, establish out of such corporate revenues any additional · Fellowship or Fellowships-

- (1) of any of the classes of Fellowships authorized by these Statutes (including that de-scribed in clause 19a of this Statute); or
- (2) of a kind not authorized by these Statutes, but solely regulated as to mode of election, tenure, duration, emoluments and other matters by such conditions as the Principal and Fellows may prescribe. Provided that no such Fellowship as last described shall be established unless it subserve some University purpose, and that in no case shall the emoluments attached to such Fellowship exceed £200 per annum, exclusive of any dinner allowance.

Not more than six additional Fellowships shall be established or maintained under the provisions of this clause, and the Principal and Fellows may, if having regard to the financial position of the College they think fit, at any time upon the occurrence of a vacancy in any such Fellowship suspend the same either permanently or during a limited period. Provided that no additional Fellowship of the kind secondly above described may be suspended unless the intention of the Principal and Fellows to so suspend it shall have been communicated to the Vice-Chancellor for the information of the Hebdomadal Council, and unless the sanction of the Visitor shall have been given after consideration of any representations the Hebdomadal Council may judge it expedient to make for the interests of the University."

STATUTE V, 6, add after "the Professoriate," in line 7, " or otherwise relative to the University and conducive to the advancement of learning, science, or education."

Delete "The order of priority . . . Hebdo-madal Council," and add "Provided that if at any time there shall be established a Fellowship or Fellowships under Statute III, 29, subserving any University purpose the income for the time being payable by the College in respect thereof shall be treated as satisfying, pro tanto, the obligation of the College to the University under this clause.

STATUTE XIII, 3, add after "if he think fit," "and although the power conferred by Statute III, 29, as amended, has not been exercised in whole or in part, but not until the provisions of Statute V, 6, as amended, have been complied with."

Add after "And approved by him," "Such a scheme may embrace the creation of an additional Fellowship or Fellowships.

- (1) of any of the classes authorized by these Statutes (including that described in Statute III, 19a); or
- (2) of a kind not authorized by these Statutes, but solely regulated as to mode of election, tenure, duration, emoluments and other matters by the conditions prescribed by such scheme, provided that in no case shall the emoluments attached to such Fellowship exceed £200 per annum, exclusive of any dinner allowance."


