county of Suffolk ; and in the churchyard except as follows :-

- (a.) In wholly walled graves now existing burials may be allowed on condition that every coffin be separately enclosed by stone-work or brickwork properly cemented.
- (b.) In earthen graves now existing burials may be allowed, at their decease, of the widows and widowers of those already interred therein provided the bodies can be deposited at or below the depth of five feet without exposing coffins or disturbing human remains.
- (c.) The burial of the Reverend James Hipwell may take place at his decease in a vault or grave not less than five feet deep to be constructed on the east side of the south aisle.
