TREASURY ORDER regulating the Collection and Disposal of Fees under "The Private Legislation Procedure (Scotland) Act, 1899."

WHEREAS by section 15 of "The Private Legislation Procedure (Scotland) Act, 1899 " (62 and 63 Vict., c. 47), it is provided that the fees payable by petitioners for, and opponents of, Provisional Orders, under the Act, shall be col-lected and disposed of in such manner as the Treasury may direct:

Now, therefore, we, being two of the Lords Commissioners of Her Majesty's Treasury, in pursuance of the powers aforesaid, hereby order and direct as follows:-

1. The fees payable by petitioners for, and opponents of, Provisional Orders under "The Private Legislation Procedure (Scotland) Act, 1899," fixed by any General Order from time to time made in terms of the Act, shall be paid to the Secretary for Scotland in money, and be remitted to him in such manner as he shall direct.

2. Where a fee is prescribed as payable in respect of a specified stage of the proceedings in connection with a Provisional Order, or draft Provisional Order, the fee shall be payable as soon as the specified stage is reached.

3. All fees received shall be appropriated in aid of the Vote for the Office of the Secretary for Scotland.
