LIVERPOOL (BIRKENHEAD) FOREIGN ANIMALS WHARF REVOCATION ORDER OF 1900.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do hereby revoke their Order bearing date the fourth day of January, one thousand eight hundred and ninety-six, defining a part of the Port of Liverpool as a foreign animals wharf : Provided . that nothing herein shall be deemed to invalidate or make unlawful anything done under the said Order before the date of this revocation, or interfree with the institution or prosecution of any proceeding in respect of any offence committed "gainst, or any penalty incurred under, the said Order before the date of this revocation.
