PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS by section sixteen of "The Pluralities Act, 1838," as amended by "The Pluralities Act, 1850," it is, amongst other things, enacted, "That whenever it shall appear " to the Archbishop of the Province, with respect "to his own diocese, and whenever it shall be "represented to him by the Bishop of any "diocese, or by the Bishops of any two "dioceses, that two or more benefices, or that " one or more benefice or benefices, and one or "more spiritual sinecure rectory or rectories" "vicarage or vicarages, in his or their diocese " or dioceses, being either in the same parish or " contiguous to each other, and of which the "aggregate population shall not exceed onc "thousand five hundred persons, may, with " advantage to the interests of religion, be united " into one benefice, the said Archbishop of the " Province shall inquire into the circumstances of " the case; and if on such inquiry it shall appear " to him that such union may be usefully made, " and will not be of inconvenient extent, and that " the patron or patrons of the said benefices, sine-" cure rectory or rectories, vicarage or vicarages " respectively, is or are consenting thereto, such " consent being signified in writing under the hands " of such patron or patrons, the said Archbishop " shall, six weeks before certifying such inquiry " and consent to Her Majesty as hereinafter "directed, cause, with respect to his own diocese, "a statement in writing of the facts, and in other " cases a copy in writing of the aforesaid repre-"sentation to be affixed on or near the principal " outer door of the church, or in some public and " conspicuous place in each of such benefices, sine-" cure rectories, or vicarages, with notice to any ٤.` person or persons interested, that he, she, or they, "may, within such six weeks, show cause in writing " under his, her, or their hand or hands, to the " said Archuishop, against such union ; and if no " sufficient cause be shown within such time, the " said Archbishop shall certify the inquiry and con-"sent aforesaid to Her Majesty in Council, and "thereupon it shall be lawful for Her Majesty in "Council to make and issue an Order or Orders " for uniting such benefices, sinecure rectory or " rectories, vicarage or vicarages, into one benefice, " with cure of souls, for ecclesiastical purposes " only; and it shall be lawful for Her Majesty in "Council to give directions for regulating the "course and succession in which the patrons, if "there be more than one patron, shall present or "nominate to such united benefice, from time to " time, as the same shall become vacant."

And whereas the Lord Archbishop of Canterbury pursuant to the provisions of the said Act, hath duly prepared and laid before Her Majesty in Council a certificate in writing, bearing date the fourteenth day of November in the year of our Lord one thousand nine hundred, in the words following, that is to say:

"We the undersigned Frederick, Archbishop of the Province of Canterbury, Primate of All England and Metropolitan do hereby certify to to Your Majesty in Council,-

"That the kight Reverend John Lord Bishop of Saint Davids as Bishop of the diocese within which are situate the vicarage of Jeffreyston and the vicarage of Reynoldston both in the county of Pembroke having represented unto us that the said benefices being contiguous to each other and of which the aggregate population does not exceed as the same shall become vacant shall be as

fifteen hundred persons may with advantage to the interests of religion be united into one benefice we enquired into the circumstances of the case.

"That on such enquiry it appeared to us that such union might be usefully made and is not of inconvenient extent and that the Dean and Chapter of the Cathedral Church of Saint Davids being the patrons or persons entitled to present to the vicarage of Jeffreyston and Sir Charles Edward Gregg Philipps Baronet and Mary Philippa Lady Philipps being jointly or one or both the patrons or persons entitled to present to the vicarage of Reynoldston respectively consent to the proposed union.

"That six weeks and upwards before certifying such enquiry and consent to Your Majesty in Council we caused a copy in writing of the afore-: said representation of the said Lord Bishop to be affixed on the principal outer door of the parish church of each of the said benefices with notice to any person or persons interested that he she or they might within such six weeks show cause in writing under his her or their hand or hauds to us the said Archbishop against such union and no sufficient cause has been shown.

"The representation of the said Lord Bishop of Saint Davids, our enquiry into the circumstances of the case, the statement of circumstances in reply thereto, the consent in writing of the said patrons and the copies of the representation and notices before mentioned are hereunto annexed.

"And we do hereby certify the enquiry and consent aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do make and issue an Order for uniting the said benefices into one benefice with cure of souls for ecclesiastical purposes and for declaring that the course and succession in which the respective patrons for the time being shall present to the said benefices after the same shall be united into one benefice from time to time as the same shall become vacant shall be as follows that is to say that the Dean and Chapter of the Cathedral Church of Saint Davids shall have two turns out of every three of the said right of presentation and that Sir Charles Edward Gregg Philipps Baronet and Mary Philippa Lady Philipps both of Picton Castle in the county of Pembroke (being jointly or one or both the patrons or persons now entitled to present to the said vicarage of Reynoldston) or other the owner or owners for the time being of the Picton Castle Estate in the county of Pembroke or other the person or persons who but for the union of the said benefices would have the right of presentation to the vicarage of Reynoldston aforesaid shall have the third or remaining turn of the said right of presentation and that the said Dean and Chapter shall have the first two turns of such right of presentation including the right to present upon the present vacancy."

Now therefore Her Majesty in Council by and with the advice of Her said Council is pleased to order as it is hereby ordered that the vicarage of Jeffreyston and the vicarage of Reynoldston both being situate in the county of Pembroke and the diocese of Saint Davids shall be united into one benefice with cure of souls for ecclesiastical purposes only.

And Her Majesty in Council by and with the advice of Her said Council is further pleased to order and direct that the course and succession in which the respective patrons for the time being shall present or nominate to such united benefice
