follows, that is to say:—the Dean and Chapter of the Cathedral Church of Saint Davids shall have two turns out of every three of the said right of presentation, and Sir Charles Edward Gregg Philipps Baronet and Mary Philippa Lady Philipps both of Picton Castle in the county of Pembroke (being jointly or one or both the patrons now entitled to present to the said vicarage of Reynoldston) or other the owner or owners for the time being of the Picton Castle Estate in the county of Pembroke, or other the person or persons who but for the union of the said benefices would have the right of presentation to the vicarage of Reynoldston aforesaid shall have the third or remaining turn of the said right of presentation and the said Dean and Chapter shall have the first two turns of such right of presentation including the right to present upon the present vacancy.

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the eighth day of November, in the year one thousand nine hundred, in the words following, that is to say:—

"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Your Majesty, chapter forty-nine; and of the Act of the nine-teenth and twentieth years of Your Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Andrew, situate within the limits of the parish of Bromley Saint Leonard in the county of Middlesex and in the diocese of London.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Andrew, Bromley Saint Leonard situate as aforesaid.

"Now therefore, with the consent of the Right Honourable and Right Reverend Mandell Bishop of the said diocese of London (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said parish of Bromley Saint Leonard which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Andrew Bromley Saint Leonard situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Andrew, Bromley Saint Leonard.'

"And with the like consent of the said Mandell, Bishop of the said diocese of London (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony

should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Andrew, Bromley Saint Leonard situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Andrew,

Bromley Saint Leonard, being :-

"All that part of the parish of Bromley Saint Leonard in the county of Middlesex and in the diocese of Lundon which is bounded upon the south-west by the new parish of All Hallows, Bromley, in the said county and diocese upon the south by the new parish of Saint Michael and All Angels, Bromley, in the same county and diocese, upon the east partly by the new parish of Saint Gabriel, Canning Town, and partly by the parish of West Ham both in the county of Essex and in the diocese of Saint Albans, and upon the remaining side that is to say upon the north by an imaginary line commencing upon the county and diocesan boundary which divides the last-mentioned parish from the parish of Bromley Saint Leonard aforesaid at a point at the centre of the bridge which carries the main line of the London Tilbuy and Southend Railway over the River Lea and extending thence westward along the middle of the said line of railway for a distance of twenty-three chains or thereabouts to Bromley Junction where it is joined by the Bromley and Bow branch of the North London Railway and extending thence north-westward along the middle of the last-named line of railway for a distance of twelve chains or thereabouts to a point opposite to the eastern end of the wall or fence forming the northern boundary of the houses and gardens on the north side of Burdettstreet and extending thence south-westward to and along the said wall or fence for a distance of two and a half chains or thereabouts to its southwestern end and continuing thence in precisely the same direction and in a straight line for a distance of three and a quarter chains or thereabouts to a point in the middle of the main line of the said North London Railway and extending thence south-eastward along the middle of the last-mentioned line of railway for a distance of one chain and a half or thereabouts to the centre of the bridge which carries the main line of the said London Tilbury and Southend Railway over the main line of the North London Railway aforesaid upon the boundary which divides the said parish of Bromley Saint Leonard from the new parish of All Hallows Bromley aforesaid.

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the
