time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her Majesty, chapter thirty seven, duly prepared and laid before Her Majes y in Council a scheme, bearing date the eighth day of November, in the year one thousand nine hundred, in the words following, that is to say :-

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the sixth and seventh years of Your Majesty chapter thirtyseven have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken out of the four parishes of Witley Chiddingfold Haslemere and Thursley all in the county of Surrey and in the diocese of

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular portions of the said four parishes of Witley Chiddingfold Haslemere and Thursley which are hereinafter mentioned and described should be constituted a separate district in manner hereinafter set forth.

"And whereas there is not at present within the limits of the said proposed district any consecrated church or chapel in use for the purposes of Divine worship.

"And whereas we are satisfied that the said hereinbefore mentioned parishes are cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof.

"And whereas Alfred Hugh Harman of Lower Grayswood in the said parish of Haslemere Esquire has contributed and paid to the credit of our account at the Bank of England a capital sum of five thousand pounds as and for an endowment for the Minister for the time being of the said district, and so soon as the said district shall have become a new parish under the provisions of the hereinbefore mentioned Act then for the Incumbent of the said new parish.

"And whereas we have in respect of the abovementioned capital sum of five thousand pounds agreed and undertaken to provide and pay by equal quarterly payments on the first day of February on the first day of May, on the first day of August and on the first day of November in each and every year to such Minister or Incumbent as aforesaid when duly licensed in accordance with the provisions of the said hereinbefore mentioned Act the sum of one hundred and fifty pounds in each and every year during which the said capital sum shall continue in our hands.

"And whereas the said sum of five thousand pounds has been so contributed and paid as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of patronage of the said district or or Incumbent thereof should be assigned in the manner hereinafter mentioned.

"And whereas the said Alfred Hugh Harman has nominated to us the said Ecclesiastical Commissioners as the persons in whom it is desired that the said right of patronage and nomination should be vested himself the said Alfred Hugh Harman for the first turn only of patronage and. nomination and the Right Reverend Randall Thomas Bishop of the said diocese of Winchester and his successors Bishops of the same diocese for the second and all subsequent turns of patronage and nomination of the said proposed district.

"Now therefore with the consent of the said-Randall Thomas Bishop of the said diocese of Winchester (in testimony whereof he has signed and sealed this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that all those portions of the said parish of Witley of the said parish of Chiddingfold of the said parish of Haslemere and of the said parish of Thursley which are mentioned and described in the Schedule hereunder written and are delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of Grayswood.'

"And we further recommend and propose that the whole right of patronage of the said district so recommended to be constituted and so soon as the said district shall have become a new parish as aforesaid then of the said new parish and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and become vested in and may be exercised for the first turn only by the said Alfred Hugh Harman and for the second and every subsequent turns of patronage and nomination in the said Randall Thomas Bishop of the said diocese of Winchester and his successors Bishops of the same diocese for ever.

" And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in conformity with the provisions of the said Act or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Grayswood comprising:-

"All those several contiguous portions of the parish of Witley of the parish of Chiddingfold, of the parish of Haslemere and of the parish of Thursley, all in the county of Surrey and in the diocese of Winchester which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said parish of Thursley from the parish of Witley aforesaid at the point on the southern side of the high road called Park-lane leading from Sandhills towards Hindhead where the said boundary turns sharply towards the north along the eastern boundary of Park-lane Cottages and extending thence in a direction due south and in a straight line across Park Copse for a distance of seventeen chains or thereabouts to a point in the middle of the stream called Wareham Brook flowing past Witley Park new parish and of the nomination of the Minister | Farm and through Park Copse aforesaid towards
