MERSEY CONSERVANCY ACT.

I HEREBY give notice, pursuant to the 9th section of the Act 5 and 6 Victoria, cap. 110, intituled "An Act for better preserving the Navigation of the River Mersey," that I have received a notice from the Trustees of the late John Hutchinson, given pursuant to the provisions of the above-mentioned Act, of their intention to construct an Embankment at Widnes, in accordance with a plan and sections deposited at this office, a copy of which notice is subjoined.

IN pursuance of an Act for better preserving the Navigation of the River Mersey (5 and 6 Victoria, cap. 110), we, the Trustees of the late John Hutchinson, of Dittou-road-chambers, Widnes, hereby give you notice that we propose to construct at Widnes, in accordance with plans and sections deposited at the office of the Mersey Conservancy, an embankment composed of slag (a perfectly vitrified substance insoluble in water, the liquid when cool drawn from copper; a heavy material weighing about 1½ tons to the cubic yard as tipped) along the dotted red line marked A.B. on the plan, in order to prevent the erosion of the adjacent land by the tidal action of the river, and to enclose the area inside the proposed embankment and coloured green on the plan.

This work will exclude the waters of the Mersey to the extent of about 20,000 cubic yards when the tide rises to 21 feet. It is intended to proceed with the work when the requisite authority has been obtained.
