

Board of Trade (Fisheries and Harbour

Department), London, January 18, 1901. THE Board of Trade have received, through. the Secretary of State for Foreign Affairs, a copy of a Telegram from Her Majesty's Representative at Galatz, intimating that ten days' quarantine is imposed on arrivals from Constantinople and Smyrna at Sulina, owing to plague.

Board of Trade (Fisheries and Harbour Department), London, January 18, 1901. THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following copy of a Telegram from Her Majesty's Representative at Bucharest, viz. :-

"Arrivals from Constantinople not admitted at

Constantza, and only at Sulina after ten days quarantine. Ships from non-infected places which pass through Bosphorus without communication with shore will be received even at Constantza.

"Importation of following articles prohibited from Smyrna and Constantinople (1) used linen, clothing, bedding (2) rags, even after hydraulic pressing and transported in bales (3) used sacks, carpets and embroideries (4) hides, untanned, raw (5) animal products, as bones, horns, hoofs, claws, bladders, guts, either raw, undried, or unsalted, having character of animal waste, horses (6) human hair (7) raw wool, fur, cotton, cordage (8) fruit, vegetables, preserves. Arrivals from Smyrna subjected to ten days' quarantine at Sulina."

Board of Trade (Fisheries and Harbour Department), London, January 18, 1901.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram from Her Majesty's Representative at St. Petersburg to the effect that he has received the following information from Odessa, viz. :-" Ten days' quarantine imposed on arrivals from Constantinople which have communicated with Constantinople counting from time of departure."

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following Telegram from Her Majesty's Representative at Constantinople, viz. :-- " Quarantine against Smyrna suppressed; disinfection and medical inspection on arrivals from Smyrna.

Board of Trade (Fisheries and Harbour Department), London, January 18, 1901.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following Telegram from Her Majesty's Representative at Belgrade, viz. :---"Owing to plague at Constantinople the Servian Government has forbidden the importation and transit from infected districts of samples and postal packages; passengers who enter Servian trains at the Turkish frontier are subjected to medical inspection, and arrivals from infected districts are placed under medical supervision for twelve days in the place of their abode. Passengers' luggage is to be disinfected."
