Master or Deputy Master of the Mint, or in the case of a brauch mint the Master of the Mint or the Deputy Master of the branch mint, to set apart or cause to be set apart coins with a view to the trial of the Pyx, and any person so appointed shall, so far as his appointment extends, act for the purpose under "The Trial of the Pyx Order in Council, 1871," as amended by this Order, in the place of the Mister or Deputy Master of the Mint, or in the case of a branch mint the Master of the Mint or the Deputy Master of the branch mint.

4. The coins to be set apart for the trial of the Pyx shall consist in the case of gold coins of one from every two thousand pieces ready for issue instead of one from each journey weight as provided by "The Trial of the Pyx Order in Council, 1871."

£ 5. The trial of the Pyx may be adjourned by the King's Remembrancer or Master presiding at the trial from time to time and from place to place.

6. This Order shall come into force upon the first day of April one thousand nine hundred and one.

## PRESENT.

The KING's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fitteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nameteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared for the purpose of being laid before Her said late Majesty in Council a representation, bearing date the eighth day of November in the year one thousand nine hundred in the words following; that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Your Majesty, chapter seventy, of the Act of the fourteenth and lifteenth years of Your Majesty, chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Luke Grayshott situate within the limits of the parish of Headley in the county of Southampton and in the diocese of Winchester.

"Whereas at certain extremities of the said parish of Headley of the new parish (sometime district) of Saint John Churt and of the new parish (sometime particular district) of Saint Stephen Shotter Mill, which two last-named cures are in the county of Surrey and in the diocese of Winchester aforesaid, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parish and of such new parishes respectively.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said parish of Headley of the said new parish of Saint John Churt, and of the said new parish of Saint Stephen Shotter Mill, should be formed junction of the same road with the road leading to Stony Castle Cottages and extending thence westward along the middle of the last-described road for a distance of forty-nine chains or thereabouts east of Stony

into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of Saint Luke Grayshott situate as aforesaid.

"Now, therefore with the consent of the Right Reverend Randall Thomas Bishop of the said diocese of Winchester as such Bishop (in testimony whereof he has signed this representation and has caused his episcopal seal to be affixed hereto) with the consent of the Provost and Scholars of Queen's C. llege in the University of Oxford, as the patrons of the rectory of the said parish of Headley (in testimony whereof they have caused their common or corporate seal to be affixed to this representation) and with the consent of the Venerable John Henry Sapte Archdescon of Survey in the said diocese of Winchester and as such Archdeacon the patron both of the vicarage of the said new parish of Saint John Churt, and of the vicarage of the said new parish of Saint Stephen Shotter Mill (in testimony whereof he has signed and scaled this representation), we, the said Ecclesiastical Commissioners for Englard, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Headley, of the said new parish of Saint John Churt and of the said new parish of Saint Stephen Shotter Mill which are described in the Schedule hereunder written, all which portions together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed should be united and formed into one consolidated chapelry for the said church of Saint Luke Grayshott situate as afore-aid and that the same should be named 'The Consolidated Chapelry of Saint Luke Grayshott.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Luke Grayshott, comprising:-

"All those contiguous portions of the parish of Headley in the county of Southampton and in the diocese of Win hester, of the new parish of Saint John Churt, and of the new parish of Saint Stephen Shotter Mill both in the county of Surrey and in the diocese of Winchester aforesaid which said portions are comprised within and are bounded by an imaginary line commencing at the point upon the western side of Hindhead Common in the middle of the high road from London to Portsmouth where the boundaries of the said new parish of Saint John Churt of the said new parish of Saint Stephen Shotter Mill and of the parish of Thursley, in the said county of Surrey and in the diocese of Winchester aforesaid all meet, and extending thence westward along the middle of the said high road for a distance of twelve chains or thereabouts to its intersection near the Royal Huts Hotel by the road leading from Shotter Mill past Hindhead School towards Frensham Common and extending thence north-westward along the middle of the last-described road for a distance of twenty-one chains or thereabouts to a point nearly opposite to the entrance to the grounds of the house called or known as 'The Croft' at the junction of the same road with the road leading to Stony Castle Cottages and extending thence westward along the middle of the last-described road for a distance of forty-nine chains or thereabouts to a point on the same road at a distance of
