Sussex College, Cambridge, amending certain Statutes of the College, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions contained in "The Universities of Oxford and Cambridge Act, 1877":—

STATUTE to alter and amend the Statutes of Sidney Sussex College in the University of Cambridge such amending Statute being duly made at a general meeting of the Governing Body of the said College specially summoned for this purpose and held on the twenty-second day of December one thousand nine hundred and passed at such meeting by the votes of more than two-thirds of the number of persons present and voting and now submitted for the approval of Her Majesty the Queen in Council.

We the Master Fellows and Scholars of the College of the Lady Frances Sidney Sussex in the University of Cambridge do hereby in exercise of the powers given to us by the fifty-fourth section of "The Universities of Oxford and Cambridge Act 1877" after and amend the existing Statutes of our said College in the following

By repealing section 6 of Statute X intituled "Tutor and Lecturers" by substituting therefor the following section to form an amended section 6 of the same Statute.

6. The number of College Lecturers shall not be more than half the full number of Members of the Governing Body and there shall be at least one in Theology, one in Classics, one in Mathematics and one in Natural Science. In addition to the College Lecturers the Governing Body may appoint from time to time such Assistant Lecturers as they may think fit.

The College Lecturers and Assistant Lecturers shall take such part in the instruction of the Students of the College in their respective studies as the Governing Body may from time to time determine.

By repealing section 10 of the same Statute X and substituting therefor the following section to form an amended section 10 of the same Statute.

10. The Governing Body shall assign to each of the College Lecturers, except the Senior College Lecturer in Mathematics and the Senior College Lecturer in Natural Science, out of the General Fund of the College yearly stipends of not less than fifty pounds (£50) or more than one hundred and fifty pounds (£150) and such stipends may be altered from time to time by the Governing Body within these limits.

By repealing Statute XXIV intituled "Of the Taylor Lectureship Estate" and by substituting

therefor the following Statute to form an amended Statute XXIV.

## CHAPTER XXIV.

OF THE TAYLOR LECTURESHIP ESTATE.

The Senior College Lecturer in Mathematics and the Senior College Lecturer in Natural Science shall receive each a moiety of the proceeds of the Taylor Lectureship Estate and shall be called the Taylor Lecturer in Mathematics and the Taylor Lecturer in Natural Science respectively. And shall retain the rights and privileges of College Lecturers as specified in these Statutes.
