describing the mode in which it appears to us the alterations may best be effected and how the alterations consequent thereon in respect of ecclesiastical jurisdiction glebe lands and other ecclesiastical dues and payments and in respect of patronage may be made with justice to all parties interested. And we do hereby submit the same to your Grace together with the consents in writing of the patrons and incumbents of both the said benefices to the intent that if your Grace shall on full consideration and enquiry be satisfied with such scheme you may certify the same and such consents by your report to ilis Majesty in Council."

And whereas the said scheme drawn up by the said Bishop and the consents referred to in the said representation are as follows:-

"SCHEME.

"That the portion of the parish and benefice of Yateley proposed to be separated therefrom and annexed for ecclesiastical purposes to the parish and benefice of Hawl-y consists of that part of Frogmore. Blackwater and Starveacre which is verged red on the Ordnance Sheet or Plan hereto annexed and which lies to the east of an imaginary line commencing at a point in the Blackwater River to the west of the Reading Branch of the South Eastern Railway at the 'Ford' and running thence southward along the centre of the road from such 'Ford' towards Frogmore and continuing along such road to the south-west corner of Bailey's rarm and thence south-east in a straight line to the north-eastern corner of the boundary between the parishes of Hawley and Yateley and thence from that point first south-east and then south along the parish boundary between Ya eley and Hawley to the southern angle of Yateley parish near Hawley Pond verged red on the Ordnance Sheet or Plan hereto annexed.

"That the Incumbent of the benefice of Hawley shall have the sole and exclusive cure of souls within the limits of the portion of the parish of

Yateley proposed to be separated.

"That marriages baptisms churchings and burials shall be selemnized in the church of the parish of Hawley for the inhabitants of the portion of Yateley proposed to be separated and all fees dues ecclesiastical offerings and emoluments arising therefrom shall henceforth belong to the Incumbent of the benefice of Hawley aforesaid.

"CONSENTS.

"We Randall Thomas by Divine permission Lord Bishop of Winchester being the patron or person entitled to present in right of our Bishoprick to the benefice of Yateley in the county of Hants and our diocese of Winchester if the same were now vacant and John Charles Randell of Hawley Blackwater Hants Esquire the patron or person entitled to present to the benefice of Hawley in the same county and diocese if the same were now vacant the Reverend Charles Drummond Stooks the vicar of Yateley and the Reverend John Ingram Penfold Wyatt the perpetual curate of Hawley do hereby signify to your Grace our consent to the scheme above proposed and set forth and to every matter and thing therein con-

"That the Right Reverend Randall Thomas Lord Bishop of Winchester as Bishop of the diocese within which are situate the benefice (being a vicarage) of Yateley and the benefice (being a perpetual curacy) of Hawley both in the county of Hants having represented unto us that there belongs to the benefice of Yateley a district the boundaries of which are well known and defined and which includes part of Frogmore and part of Blackwater and Starveacre and more particularly set out in the scheme hereunto annexed drawn up by the said Lord Bish p may be advantageously separated from the parish of Yateley and annexed to the contiguous parish of Hawley for ecclesiastical purposes only under the provisions of 'The Piuralities Acr 1838.'

" That pursuant to the directions contained in the said Act the said Lord Bishop has drawn up the said scheme in writing describing the mode in which it appears to him that the proposed alteration may best be effected and how the changes consequent on such alteration in respect to eccle-last cal jurisdiction glebe lands tithes rentcharges and other ecclesiastical dues rates and payments and in respect to patronage and rights to pews may be made with justice to all parties interested which scheme together with the consents thereto in writing of the said Lord Bishop as the patron or person entitled to present in right of his Bishoprick to the said benefice of Yateley in case the same were now vacant and John Charles Randell of Hawley Blackwater Hants Esquire as the patron or person entitl d to present to the said benefice of Hawtey in case the same were now vacant and of the Reverend Charles Drummond Stooks the vicar of Yateley and the Reverend John Ingram Penfold Wyatt the perpetual curate of Hawley has been transmitted to us by the said Lord Bishop for our consideration.

"The representation and scheme of the said Lord Bishop and the consents before referred to are hereunto annexed.

"And we the said Archbishop being on full consideration and enquiry satisfied with the said scheme do hereby pursuant to the said Pluralities Act 1838 certify the same and such consents as aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do make and issue an Order for carrying the said scheme into effect.
