the middle of the last-named road for a distance of two chains and a quarter or thereabouts to its junction with Crescent-road and extending thence eastward along the middle of the last-named road for a distance of thirteen chains or thereabouts to its junction with the road called Moss Bank and extending thence north-castward along the middle of the last-named road for a distance of five chains or thereabouts to the boundary which divides the said new parish of Saint Mark Cheetham Hill from the new parish of Saint Mary Crumpsall aforesaid.

"II. And also all that further portion of the said new parish of Saint Mark Cheetham Hill which is bounded upon the greater part of the west upon the north and upon the north-east by the said new parish of Saint Mary Crumpsall and upon the remaining sides that is to say upon the south and upon the remaining part of the west by an imaginary line commencing upon the boundary which divides the said new parish of Saint Mary Crumpsall from the new parish of Saint Mark Cheetham Hill aforesaid at or near the point where the road leading from Manchester Workhouse is joined by the footpath leading to and along the south side of the recreation ground called or known as Crumpsall Park and extending thence westward along the middle of the said footpath for a distance of eighteen chains or thereabouts to its junction with Oak-road and extending thence northward along the middle of the last-named road for a distance of one chain or thereabouts to the boundary which divides the said new parish of Saint Mark Cheetham Hill from the new parish of Saint Mary Crumpsall aforesaid.

"The SECOND SCHEDULE.

"The territory to be dissevered from the said new parish of Saint Mark Cheeti am Hill, and to be annexed to the new parish of Saint Thomas Lower Crumpsall in the county and diocese aforesaid being :-

"All that portion of the said new parish of Saint Mark Cheethem Hill which is bounded upon the south partly by the new parish of Saint Luke Cheetham Hill in the said county and diocese and partly by the new parish of Saint Thomas Lower Crumpsall aforesaid upon the east by the last-named new parish and upon the remaining sides that is to say upon the north and upon the west by an imaginary line commencing at or near the point where the boundaries of the snid new parish of Saint Thomss Lower Crumpsall, the said new parish of Saint Mary Crump-all, and the new parish of Saint Mark Cheetham Hill aforesaid all meet where the road leading from Manchester Workhouse is joined by the footpath leading to and along the south side of the Recreation Ground called or known as Crumpsall Park and extending thence westward along the middle of the said footpath for a distance of eighteen chains or thereabouts to its junction with Oak-road and extending thence southward along the middle of Oak-road aforesaid for a distance of eleven chains or thereabouts to its junction with Crescent road aforesaid and extending thence south-eastward along the middle of the last-named road for a distance of one chain and a quarter or thereabouts to its junction with the footpath which leads under the Presiwich Branch Line of the Lancashire and Yorkshire Railway to Woodland-road and extending thence south westward along the middle of the said footjin h for a distance of seventeen chains or thereabouts to its junction with the last-named road as aforesaid upon the boundary which divides the said new parish of Saint Mark

Cheetham Hill from the new parish of Saint Luke Cheetham Hill aforesaid."

And whereas drafts of the said scheme or representation have been transmitted to the pairons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by His Majesty in Council; now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme or representation and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act ; and His Maj sty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchest r.

The KING's Most Excellent Majesty in Council.

V HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty chapter one hundred and fourteen duly prepared and laid before His Maj-sty in Council a scheme bearing date the twentyfirst day of February, in the year one thousand nine handred and one, in the words following, that is to say :-

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the thirtythird and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned that is to say, the Act of the third and fourth years of Her said late Majesty chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty chapter thirty-nine and the Act of the. thirty-first and thirty-second years of Her said, late Majesty chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Conway, in the county of Carnarvon and in the diocese of Bangor,

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Conway is vested for an estate in fee simple. without incumbrances in Sir Thomas Erskine, of Cambo, in the county of Fife, Baronet, and his heirs and assigns.

"And whereas the said Thomas Erskine is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Conway now vested in him as aforesaid should be transferred to and be vested in the Bishop for the time being of the said diocese of Bangor.
