

thence in a northerly direction along the centre of Grammar-street to Greaves-street, thence in a westerly direction along Freedom-street to Burnaby-street, thence across Burnaby-street and along a line in a north-westerly direction to a point at the junction of Walkley-lane and Morley-street, thence in a south-westerly direction along the centre of Morley-street to its junction with Walkley Bank-road, thence in a westerly direction along the centre of a certain road and public foot-path to the centre of the River Rivelin at a bridge opposite the Mouse Hole Forge, thence in a south-westerly direction along the centre of the River Rivelin to the new City boundary at the south-western corner of the field No. 469 near the Stepping Stones, thence following the new City boundary to the River Don in a north-easterly direction, thence in a south-easterly direction along the centre of the River Don to the point of commencement aforesaid.

"And I do hereby declare that the sixteen Wards aforesaid the said boundaries of which are hereinbefore determined and defined, are shown upon six Ordnance maps (large scale) marked respectively with the letters A to F inclusive, and which six Ordnance maps have been signed by me, and the said boundaries of the said sixteen wards are clearly set forth by lines coloured "red" thereon. And I do hereby further declare that the said six Ordnance maps have been deposited by me with the Town Clerk of the said city of Sheffield; and I do hereby assign and apportion three Councillors to each and every of the said sixteen Wards as follows, that is to say:—
