RAILWAY EMPLOYMENT (PREVENTION OF ACCIDENTS) ACT, 1900.

- 6. Protection of point rods and signal wires, and position of ground levers working points.
- 7. Position of offices and cabins near working

8. Marking of fouling points.

- 9. Construction and protection of gauge glasses. 10. Arrangement of tool boxes and water gauges
- on engines. 11. Working of trains without brake vans upon
- running lines beyond the limits of stations. 12. Protection to permanent way men when relaying or repairing permanent way.
