All Birds protected on Sundays and on Christmas
Day throughout the County Borough.

IV. During the period between the 31st day of July in any year and the 2nd day of March following, the killing or taking of Wild Birds on Sundays and on Christmas Day is prohibited throughout the County Borough of Portsmouth.

## EGGS.

Certain Eggs protected throughout the County Borough.

V. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the County Borough of Portsmouth:—

Common Buzzard, Honey Buzzard, Kingfisher, Montagu's Harrier, Nightingale, Owl, Woodpecker, Dartford Warbler, Oriole, Raven, Goldfinch, Lesser Redpoll, Crossbill, Nightjar, Hoopoe, Marsh Harrier, Hobby, Merlin, Nuthatch, Kestrel, Common Heron, Night Heron, Bittern (all species), Wild Duck (all species), Sheldrake, Sand Grouse, Quail, Stone Curlew, Lapwing (after April 30th), Redshank, Curlew, Tern (all species), Black-headed Gull, Great Crested Grebe.
