## NOTICES TO MARINERS.

(Nos. 318 to 331 of the year 1901.)

[The bearings are magnetic, and those concerning the visibility of lights are given from seaward.]

No. 318.—BRAZIL—ILHA GRANDE.

*Castelhanos Point—Light Exhibited.*

THE Brazilian Government has given notice, that on 6th April, 1901, a white fixed and group flashing light, showing two flashes in succession every thirty seconds, would be exhibited from a lighthouse recently erected on Castelhanos Point, Ilha Grande; it is elevated 347 feet above high water, and visible in clear weather from a distance of 25 miles from the bearing of S. 24° E., through south and west, to N. 34° E.

The light is dioptric of the 3rd order, and shown from a quadrangular tower, 53 feet high, painted white, with dwelling adjoining it.

Approximate position, lat. 23° 9' 50" S., long. 44° 5' 25" W.

No. 319.—BRAZIL—ILHA GRANDE BAY.

*Jacucanga Bay—Rocks Reported.*

THE Brazilian Government has given notice, dated 22nd March, 1901, of the existence of the following rocks in Jacucanga Bay:—

a. Bernardo Rock, with a depth of 2 fathoms over it, situated with Saracura Island centre bearing S. 32° W., distant 1 mile, and East Point extremity S. 34° E.

b. Badejo Rock, with a depth of 4 fathoms over it, situated with Saracura Island centre bearing S. 68° W., distant 4½ cables, and East Point S. 85° E.

There is another rock, with a depth over it of 4 fathoms, situated at a distance of 1 cable N. 68° W. from the above.

c. Laginha Rock, with a depth of 5½ fathoms over it, situated with Saracura Island centre bearing S. 29° W., distant 2½ cables, and East Point S. 83° E.

d. Saracura Rock, with a depth of 4 fathoms, situated with Saracura Island summit bearing N. 58° E., distant 3½ cables.

e. Baixa Rock, with a depth of 2½ fathoms over it, situated with Homens North Rock bearing about S. 28° E., distant 2¾ cables, and Peregrino Island summit N. 67° E.

Approximate position, Saracura Island, lat. 23° 3' S., long. 44° 16' W.

No. 320.—IRELAND—EAST COAST.

*South Arklow Light-Vessel—Intended Alteration in Light.*

THE Commissioners of Irish Lights have given notice that, on or about 1st November, 1901, the period of the light (white revolving) exhibited from the South Arklow Light-vessel will be altered from thirty seconds to forty-five seconds.
