

said in the Maidstone-road proceeding thence in a southerly direction along the boundary of Saint Margaret Ward as hereinbefore defined to a point in the said road at the south-western angle of Saint Margaret's Cemetery thence in an easterly direction along the footpath on the south side of the said Cemetery to the south-eastern angle of the said cemetery thence in a northerly direction along the eastern side of the Saint Margaret's and Saint Nicholas' Cemeteries to Cecil-road thence continuing in a northerly direction to Cossack-street Burritt-street (leaving the Delce Corn Mill in Saint Peter's Ward hereinafter defined) Prince's-street and Castle-avenue to a passage on the south side and in rear of Rochester-avenue thence in a westerly direction along the said passage to a passage leading in a northerly direction to and across Rochester-avenue to a passage at the rear of the houses on the north side of Rochester-avenue thence in an easterly direction along the said passage to Delce-road thence in a northerly direction along the centre of Delce-road and of Star Hill to the boundary of Saint Nicholas Ward as hereinbefore defined thence in south-westerly and north-westerly directions successively along the southern boundary of Saint Nicholas Ward to the point of commencement aforesaid.

" Saint Peter's Ward.

" Saint Peter's Ward shall include so much of the said city of Rochester as is contained within an imaginary line commencing at a point in the southern boundary of Saint Nicholas Ward as hereinbefore defined at the junction of Star Hill and Orange-terrace proceeding thence in a south-easterly direction along the said boundary to a point hereinbefore defined in the wall of Saint Margaret's Banks near the Chatham Station of the South Eastern Railway Company's line thence in a northerly direction along the boundary of Saint Nicholas Ward to the centre of the channel of the River Medway thence in an easterly direction along the centre of the channel to a point on the boundary of the parish of Chatham opposite to the eastern boundary of the city of Rochester by land at Boundary Wharfe thence in a southerly direction along the eastern and southern boundaries of the city to the Maidstone-road thence in a northerly direction along the boundary of Saint Margaret Ward as hereinbefore defined to the south-western angle of the Saint Margaret's Cemetery aforesaid thence along the southern and eastern boundaries of Troy Town Ward as hereinbefore defined to the point of commencement aforesaid.

" Strood Ward.

" The Strood Ward shall include so much of the said city of Rochester as is contained within an imaginary line commencing at a point in the western boundary of Saint Nicholas Ward as hereinbefore defined at a point aforesaid in the centre of the channel of the River Medway above the Rochester Esplanade Pier proceeding thence in a north-easterly direction along the centre of the channel of the said river to the north-eastern side of the railway bridge carrying the London Chatham and Dover Railway Company's line over the said river thence in a north-westerly direction along the north-eastern side of the said railway to North-street thence in a northerly direction along the centre of North-street to Gun-lane thence in a south-westerly direction along the centre of Gun-lane to Brompton-lane thence in a north-westerly direction along the centre of Brompton-lane to the northern boundary of the city thence in westerly and south-easterly directions successively along the boundary of the city by land to a point in the centre of the River Medway on the boundary

of Saint Margaret Ward hereinbefore defined thence in a north-easterly direction along the northern boundary of Saint Margaret Ward aforesaid to the point of commencement aforesaid.

" Frindsbury Ward.

" The Frindsbury Ward shall include so much of the said city of Rochester as is contained within an imaginary line commencing at a point in Strood Ward as hereinbefore defined at a point on the north-eastern side of the railway bridge proceeding thence in a north-westerly direction along the boundary of Strood Ward as hereinbefore defined to the northern boundary of the city thence along the boundary of the city by land in easterly and southerly directions successively to a point in the centre of the channel of the River Medway on the boundary of Saint Nicholas Ward as hereinbefore defined thence in a south-westerly direction along the northern boundary of Saint Nicholas Ward as hereinbefore defined to the point of commencement aforesaid. And it is hereby declared that nothing in this scheme referring to the boundary of the city by land in the description of the boundaries of the wards hereinbefore defined shall be taken to limit or define the jurisdiction limits or boundaries of the liberties of the old city of Rochester by water or otherwise from Sheerness to Hawkwood. And I the said Commissioner in further pursuance of the terms of the said warrant and for the purposes aforesaid do hereby assign and apportion all the existing Councillors of the said city of Rochester among the wards as hereinbefore determined of the said city as follows namely:—

" To Saint Nicholas Ward three Councillors namely:—Hubert Franklin Homan, Francis Kilvington Parker, Henry Sherwin Knight.

" To Saint Margaret Ward three Councillors namely:—Walter Edward Lakin, Frederick Francis Smith, Charles Tuff.

" To Troy Town Ward three Councillors namely:—Austen Frederick Budden, William Waters, Charles Willis, junior.

" To Saint Peter's Ward three Councillors namely:—Edward William Willis, Lewis Alexander Goldie, William James Woodman.

" To Strood Ward three Councillors namely:—George Robinson, Charles David Levy, Robert Powell.

" To Frindsbury Ward three Councillors namely:—James John Eastmead, Percy John Neate, William John McLellan.
