

in the county and diocese aforesaid and of the said parish of Saint Marylebone all meet at the junction of the road called York-place with Marylebone-road and extending thence north-eastward along the middle of the last-named road for a distance of four and three-quarters chains or thereabouts to a point directly opposite to the north-western end of the wall or fence forming the south-western boundary of the premises of the Saint Marylebone Workhouse, and extending thence generally south-eastward to and along the said wall or fence for a distance of eight and a half chains or thereabouts to its south-eastern end at the north-western end of the roadway which gives access to the Saint Marylebone Public Mortuary and Coroner's Court and extending thence south-eastward along the south-western side of the said roadway for a distance of two chains or thereabouts to the gateway at the junction of the same roadway with Paddington-street and extending thence south-eastward and in a direct line across the last-named street for a distance of eighteen yards or thereabouts to the north-western end of the wall or fence forming the south-western boundary of the disused burial-ground now used as a recreation ground and known as the Paddington-street Ground Saint Marylebone and extending thence south-eastward along the last-mentioned wall or fence for a distance of eight and a half chains or thereabouts to its south-eastern end and continuing thence still south-eastward and along the wall or fence at the backs of the houses and premises situate upon the north-eastern side of Manchester-street including the houses and premises numbered 15 and 14 Manchester-street which taken together are now known as Ford's Hotel for a distance of one chain and a quarter or thereabouts to the junction of the last described wall or fence with the wall or fence which divides the said house and premises Number 14 Manchester-street from the Marylebone Electric Lighting Station of the Metropolitan Electric Supply Company Limited, and extending thence south-westward along the last-mentioned wall or fence for a distance of twenty yards or thereabouts to its junction with the wall or fence which divides the said Electric Lighting Station from the house and premises Number 13 Manchester-street and extending thence first generally southward and then south-westward along the last-mentioned wall or fence for a distance of twenty-six yards or thereabouts to its junction with the wall or fence which divides the said Electric Lighting Station from the house and premises Number 12 Manchester-street and extending thence south-eastward along the last-mentioned wall and along the wall which divides the said Electric Lighting Station from the houses and premises numbered 11, 10, 9 and 8 Manchester-street for a distance of one chain and a half or thereabouts to its junction with the wall which divides the said house and premises Number 8 Manchester-street from the house and premises Number 19 South-street and extending thence south-westward along the last-mentioned wall and also along the wall which divides the said house and premises Number 8 Manchester-street from the public-house called or known as the Lincoln otherwise Number 20 South-street, for a distance of sixteen yards or thereabouts to the south-western end of the last-mentioned wall on the north-eastern side of Manchester-street and continuing thence in precisely the same direction and in a straight line for a distance of eight yards or thereabouts to a point in the middle of the last-named street and extending thence south-eastward along the middle of the

last-named street for a distance of one chain and a half or thereabouts to a point directly opposite to the south-western end of the wall which divides the house and premises Number 21 South-street from the house and premises Number 7 Manchester-street, and extending thence north-eastward to and along the last-mentioned wall for a distance of one chain or thereabouts to its junction with the wall or fence at the back of the said house and premises Number 7 Manchester-street, and extending thence generally southward along the last-mentioned wall or fence and along the walls or fences at the backs of the houses and premises numbered 6, 5, and 4 Manchester-street for a distance of thirty-seven yards or thereabouts to the south-eastern corner of the last-mentioned house and premises upon the northern side of the entrance to Manchester-mews South and extending thence south-eastward and in a direct line across the said entrance to the said mews for a distance of five yards or thereabouts to the north-eastern corner of the house and premises Number 3 Manchester-street and extending thence first south-eastward and then alternately south-westward and south-eastward along the wall or fence at the backs of the houses and premises numbered 3, 2, and 1 Manchester-street for a distance of thirty-seven yards or thereabouts to the south-eastern corner of the said house and premises Number 1 Manchester-street upon the north-western side of George-street and extending thence in precisely the last-mentioned direction that is to say south-eastward and in a straight line for a distance of ten yards or thereabouts to a point in the middle of the last-named street upon the boundary which divides the said parish of Saint Marylebone from the new parish of Saint Thomas Portman-square aforesaid."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.
