glebe lands, tithes, rent-charges, and other ecclesiastical dues, rates, and payments, and in respect of rights to pews, may be made with justice to all parties interested, and we do hereby submit the same to your Grace together with the necessary consents in pursuance of 'The Pluralities Act 1838,' as hereinafter appears.

ties Act 1838, as hereinafter appears.

"And in case you shall upon full consideration and enquiry be satisfied therewith, we request that your Grace will be pleused to certify the same and the consents aforesaid by your report to

His Majesty in Council."

And whereas the said scheme drawn up by the said Bishop and the consents referred to in the said representation are as follows:—

"The SCHEME.

"It is proposed to separate from the said parish of Llantrisant all that portion thereof which is edged green on the plan annexed hereto and is bounded on the north by the line drawn along the River Rhondda which now forms the boundary between the parishes of Llanwonno and Llantrisant from a point in the centre of the River Rhonda due south of the letter 'W' of Well in Hopkinstown marked in the 6-inch Ordnance Survey and due north of the point at which the stream, which flows through Gelliwion Wood, empties itself into the River Rhondda, up the river to the point in the centre of the said river where the eastern boundary of the consolidated chapelry of Cymmer and Porth crosses the said river, and then following the said boundary of the consolidated chapelry of Cymmer and Porth in a straight line in a south-south-westerly direction to the summit of Mynydd-y-Glyn at the point marked in the 6-inch Ordnance Map Sur. 1249.6 then following an imaginary straight line drawn almost due east from the last-named point to the southernmost point of the farm buildings of Landraw Farm, then passing in a north-easterly direction along the outside of the said farm buildings to the point where the figure '6' stands in B. M. 612.5 in the 6-inch Ordnance map, then following an imaginary straight line drawn almost due north from the last-named point through the figure 1 of B. M. 681.7 to the head of the small stream aforenamed in Gelliwion Wood, and following the course of the said stream in a north-north-easterly direction through the said wood to the first-named point in the centre of the River Rhondda due north of the point where the said small stream empties itself into the said

"The incumbent of the said parish of I.lanwonno shall have exclusive cure of souls within the portion of the said parish of Llantrisant so proposed to be separated therefrom and annexed to the said parish of Llanwonno and which shall be subject to the same ecclesiastical jurisdiction as the said parish of Llanwonno, and all the fees for churchings marriages and burials and other ecclesiastical offices solemnized or performed at the churches or churchyards of the parish of Llanwonno in respect of the inhabitants of the district so proposed to be annexed thereto shall belong to and continue to be received by the incumbent of Llantrisant for the time being.

"Nothing in the said scheme is to prejudice the rights of the present incumbent of Llantrisant legally entitled to the fees hereinbefore referred to except with the consent of such incumbent.

"CONSENTS.

"We Richard, Bishop of Llandaff, the patron in full right of our Bishopric of the said vicarage of Llantrisant, and the Reverend Joshua Pritchard Hughes, Clerk, M.A., the vicar of the same parish of Llantrisant, and as such the patron of the said

perpetual curacy of Llanwonno and the Reverend Llewelyn Lloyd Davies, Clerk, M.A., the incumbent of Llanwonno do hereby respectively signify our consent to the foregoing scheme for separating the portion of the said parish of Llantrisant and annexing the same to the said parish of Llanwonno for ecclesiastical purposes only.

And whereas the said Archbishop being satisfied with the said scheme hath certified the same and the consents aforesaid to His Majesty in Council by his report dated the sixteenth day of May one thousand nine hundred and one which said report is in the words and figures following:—

"We the undersigned Frederick, Archbishop of the Province of Canterbury do hereby report to

Your Majesty in Council

"That the Right Reverend Richard Lord Bishop of Llandaff has represented unto us

(amongst other things)

"That there are in the county of Glamorgan and his diocese of Llandaff the benefice or vicarage of Llantrisant and the benefice or perpetual curacy of Llanwonno.

"That it appears to the said Lord Bishop that a certain district being a portion of the parish of Llantrisant may be advantageously separated from the said parish of Llantrisant and annexed to the contiguous parish of Llanwonno for ecclesiastical purposes only under the provisions of the Plu-

ralities Acts 1838 and 1887.

"That pursuant to the directions contained in the said Acts, the said Lord Bishop has drawn up a scheme in writing describing the mode in which it appears to him the proposed alteration may best be effected and how the changes consequent upon such alteration in respect to ecclesiastical jurisdiction glebe lands tithe rent-charges and other ecclesiastical dues rates and payments and in respect to patronage and rights to pews may be made with justice to all parties interested which scheme together with the consents thereto in writing of the Right Reverend Richard Lord Bishop of Llandaff in right of his Bishoprick the patron or person entitled to present to the said vicarage of Llantrisant in case the same were now vacant and of the Reverend Joshua Pritchard Hughes M.A. the Vicar of the same parish and as such the patron or person entitled to present to the perpetual curacy of Llanwonno in case the same were now vacant and of the Reverend Llewelyn Lloyd Davies, Clerk, Incumbent of the benefice or perpetual curacy of Llanwonno, has been transmitted to us by the said Lord Bishop for our consideration.

"The representation and scheme of the said Lord Bishop and the consents before referred to

are hereunto annexed.

"And we the said Archbishop being on full consideration and enquiry satisfied with the said scheme do hereby pursuant to the said Pluralities Act 1838 certify the same and such consents as aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do make and issue an Order for carrying the said scheme into effect.
