the middle of the said last-mentioned line of railway for a distance of forty-five chains or thereabouts to the firstly hereinbefore mentioned point upon the said boundary which divides the said county of Middlesex and diocese of London from the county of Hertford and diocese of Saint Albans as aforesaid at which point the said imaginary line commenced."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts ; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

The KING's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the second day of May, in the year one thousand nine hundred and one in the words following, that is to say :--

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint Theodore situate at Port Talbot in the parish of Margam in the county of Glamorgan and in the diocese of Llandaff.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Theodore situate as aforesaid.

"Now therefore, with the consent of the Right Reverend Richard, Bishop of the said diocese of Llandaff (testified by his having signed and sealed this representation) we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Margam which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Theodore situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Theodore, Port Talbot.'

"And with the like consent of the said the same and every part thereof shall be effectual Richard Bishop of the said diocese of Llandaff in law immediately from and after the time when

(testified as aforesaid) we, the said Ecclesiastical Commissioners further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said church of Saint Theodore situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being. Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Theodore, Port Talbot, being :---

"All that part of the parish of Margam in the county of Glamorgan and in the diocese of Llandaff which is bounded upon the south-west by the sea upon the north-west partly by the parish of Aberavan and partly by the parish of Michael-ton-super-Avan, upon the north-east and upon the east by the parish of Llangynwyd all in the county and diocese aforesaid, and upon the remaining sides that is to say, upon the south and upon the south-east by an imaginary line commencing upon the boundary which divides the said parish of Llangynwyd from the parish of Margam aforesaid at the tumulus called 'Twmpath Diwlith' upon the mountain called Mynydd Margam and extending thence westward and in a straight line for a distance of one mile forty-nine chains or thereabouts to the point called or known as Ergyd Uchaf upon the same mountain and extending thence in a direction a little to the south of west and in a straight line for a distance of fifty-eight chains or thereabouts to the point called or known as Ergyd Isaf upon the mountain called Mynydd Brombil and extending thence south-westward and in a straight line for a distance of one mile six chains or thereabouts (thereby passing to the north-west of the house called Ty-fry and to the south-east of the house called Wern) to the point where the main road leading from London to Neath is joined by the parish road leading to Morfa Colliery and continuing thence still south-westward along the middle of the said parish road for a distance of fifteen chains or thereabouts to the centre of the bridge which carries the same parish road over the line of the Great Western Railway (South Wales Division) and extending thence south-eastward along the middle of the said line of railway for a distance of fifty-five chains or thereabouts to the point where such line of railway is crossed by the road called Heol-y-Deiliaid and extending thence in a direction due south-west and in a straight line for a distance of one mile twenty-seven chains or thereabouts to a point on the sea-shore at the low water mark of ordinary tides.'

And whereas the said representation has been approved by His Mnjesty in Council : now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when
