chapelry to the said church of Saint Cyprian situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Cyprian

Brockley.'

"And with the like consent of the said Edward Stuart Bishop of the said diocese of Rochester (testified as aforesaid), we the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said church of Saint Cyprian situate as aforesaid and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Cyprian

Brockley, being :-

"All that part of the parish of Lewisham in the county of Kent and in the diocese of Rochester which is bounded upon the south-west by the district of Saint Hilda Crofton Park in the county and diocese aforesaid upon the west by the new parish of Saint Catherine Hatcham situate partly in the said county of Kent and partly in the county of Surrey and wholly in the diocese of Rochester aforesaid upon the north partly by the new parish of Saint James Hatcham situate partly in the said county of Kent and partly in the said county of Surrey and wholly in the diocese aforesaid and partly by the new parish of Saint Peter Deptford in the said county of Kent and in the diocese aforesaid upon the north-east by the new parish of Saint Stephen Lewisham in the last-mentioned county and in the diocese aforesaid and upon the remaining sides that is to say upon the east and upon the south-east by an imaginary line commencing upon the boundary which divides the said new parish of Saint Stephen Lewisham from the parish of Lewisham aforesaid at the point on the eastern side of the Recreation Ground known as Hilly Fields where the footpath leading from the road called Loampit Hill joins the road called Vicar's Hill and extending thence first south-westward to and then southeastward along the fence which forms the eastern boundary of the said Hilly Fields (thereby following the western side of Vicar's Hill aforesaid) for a distance of eight and a half chains or thereabouts to its junction with the fence forming the southern boundary of the said Hilly Fields and extending thence first south-westward then westward and then again south-westward along the lastmentioned fence for a distance of fourteen chains or thereabouts to the point where it meets the fence forming the eastern boundary of the house known as Number 14 Eastern-road and called the Turret House and extending thence southward along the fence forming the eastern boundary of that house and of the other houses and premises situate on the eastern side of Eastern-road for a distance of four and a half chains or thereabouts to the point where the last-described fence joins the fence forming the northern boundary of the

houses on the northern side of Adelaide-road and numbered 31 to 67 Adelaide-road and extending thence eastward along the last-described fence for a distance of six chains or thereabouts to a point at the north-western extremity of the private roadway or footpath running along the backs of the houses on the north-eastern side of Adelaideroad aforesaid and numbered 69 to 79 Adelaideroad and extending thence south-eastward along the middle of the said private roadway or footpath for a distance of two and a half chains or thereabouts to its junction with the private roadway leading into Adelaide-road aforesaid and extending thence south-westward along the middle of the last-described private roadway for a distance of two and three-quarter chains or thereabouts thereby passing between the houses known respectively as 79 and 81A, Adelaide-road to its junction with Adelaide-road aforesaid and extending thence south eastward along the middle of the last-named road for a distance of two chains or thereabouts to its junction with Ladywell-road and extending thence eastward along the middle of the last-named road for a distance of three and a half chains or thereabouts to its junction with the roadway leading to the entrance to the Saint Olave Southwark Infirmary and Workhouse and extending thence southward along the northwestern side of the last-described roadway for a distance of two chains or thereabouts to the entrance to the same infirmary and workhouse and extending thence south-westward along the fence forming the north-western boundary of the said infirmary and workhouse for a distance of thirty-five chains or thereabouts to the point where it meets the fence forming the northeastern boundary of the Shortlands and Nunhead branch line of the South Eastern and Chatham Railway and extending thence south-westward and in a straight line for a distance of one chain or thereabouts to the middle of the said line of railway upon the boundary which divides the said parish of Lewisham from the district of Saint Hilda Crofton Park aforesaid."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chapter ninety-four of the Act of the thirteenth and fourteenth years of Her said late Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four, duly prepared and laid before His Majesty in Council a scheme or representation bearing date the twenty-third day of May, in the year one thousand nine hundred and one, in the words following, that is to say:—
