Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Bristol.

HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty second years of Her said late Majesty chapter one hundred and fourteen duly prepared and laid before His Majesty in Council a scheme bearing date the fourth day of July, in the year one thousand nine hundred and one, in the words following, that is to say:—

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the thirtythird and thirty-fourth years of Her late Majesty Queen Victoria chapter thirty-nine, and of the Acts therein mentioned that is to say, the Act of the third and fourth years of Her said late Majesty chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Upper Edmonton, in the county of Middlesex, and in the diocese of London.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Upper Edmonton is vested in the vicar or incumbent for the time being of the vicarage of the parish of Edmonton in the said county of Middlesex and in the said diocese of London.

"And whereas the Dean and Chapter of the Cathedral Church of Saint Paul in London are the patrons of the said vicarage of the parish of Edmonton.

"And whereas the said Dean and Chapter of the said Cathedral Church of Saint Paul in London are desirous that the income or incomes of one or more benefices of which they are the patrons should be apportioned in favour of the said benefice of Upper Edmonton.

"And whereas with a view to rendering such an apportionment legally practicable it is necessary that the said Dean and Chapter of the said Cathedral Church of Saint Paul in London should become the patrons of the said benefice of Upper Edmonton.

"And whereas the Reverend Ernest Arthur Blackwell Sanders Clerk in Holy Orders the present vicar or incumbent of the said vicarage of the parish of Edmonton is desirous that the whole hereby to direct that this Order be forthwith

advowson or perpetual right of patronage of and presentation to the said benefice of Upper Edmonton now vested in him as aforesaid should be transferred to and be vested in the said Dean and Chapter of the said Cathedral Church of Saint Paul in London and their successors.

"And whereas the kight Honourable and Right Reverend Arthur Foley now Bishop of the said diocese of London is willing to consent to such transfer and in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he the said Arthur Foley Bishop of the said diocese of London has executed this scheme as hereinafter mentioned.

"And whereas the transfer of the patronage of the said benefice of Upper Edmonton which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say in the new parish of

Upper Edmonton. Now therefore with the consent of the said Dean and Chapter of the said Cathedral Church of Saint Paul in London (in testimony whereof they have affixed their common or corporate seal to this scheme) and with the consent of the said Ernest Arthur Blackwell Sanders (in testimony whereof he has signed and scaled this scheme) and with the consent of the said Arthur Foley Bishop of the said diocese of London (in testimony whereof he has signed this scheme and scaled the same with his episcopal seal) we the said Ecclesiastical Commissioners for England humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice of Upper Edmonton now vested in him the said Ernest Arthur Blackwell Sanders as vicar or incumbent of the vicarage of the said parish of Edmonton and his successors vicars or incumbents of the same vicarage as aforesaid shall be transferred from him and them to the said Dean and Chapter of the said Cathedral Church of Saint Paul in London and their successors and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Dean and Chapter of the said Cathedral Church of Saint Paul in London and by their successors for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said scheme has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith
