to be annexed to the new parish of Saint Paul

West Hartlepool aforesaid being :-

"All that portion of the said new parish of Christ Church West Hartlepool which is bounded upon the west by the parish of Hart in the county and diocese aforesaid upon the south by the said new parish of Saint Paul West Hartlepool and upon the remaining side that is to say upon the east by an imaginary line commencing upon the boundary which divides the said new parish of Saint Paul West Hartlepool from the new parish of Christ Church West Hartlepool aforesaid at a point in the middle of Hart-road aforesaid opposite to the southern end of the wall forming the western boundary of the West Hartlepool Cemetery and extending thence first northward to and along the said wall for a distance of five and a half chains or thereabouts to its junction with the wall forming at this point a part of the southern boundary of the same cemetery and extending thence westward along the last described wall for a distance of three and a quarter chains or thereabouts to its western end on the eastern side of Jesmond-road and extending thence first westward to and then northward along the middle of the last-named road for a distance of ten chains or thereabouts to its junction with Chester-road and extending thence northwestward and in a straight line for a distunce of forty chains and a half or thereabouts to the point in the road leading from High Throston to the Hartlepool Union Workhouse where the boundaries of the said new parish of Christ Church West Hartlepool of the said parish of Hart and of the new parish of Holy Trinity Hartlepool in the county and diocese aforesaid all meet.

And whereas drafts of the sa'd scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively

signified their assent thereto.

And whereas the said scheme or representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Durham.

The KING's Most Excellent Majesty in Council WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her late Majesty Queen Victoria, chapter one hundred and thirteen, of the Act of the sixth and seventh years of Her said late Majesty, chapter thirty-seven, of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, and of the Act of the twenty-third and twenty-fourth years of Her said late Majesty chapter one hundred and twenty-four, duly prepared and laid before His Majesty in Council a scheme, bearing date the twenty-fifth day of July, in the year one thousand nine No. 27345.

hundred and one, in the words following, that is to say:-

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the third and fourth years of Her late Majesty Queen Victoria chapter one hundred and thirteen, of the Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven, of the Act of the nineteenth and twentieth years of Her said late Majesty chapter one hundred and four, and of the Act of the twenty-third and twenty-fourth years of Her said late Majesty chapter one hundred and twenty-four have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken out of the new parish (sometime district chapelry) of Saint Mary (Prince's-road) Lumbeth within the original limits of the parish of Lambeth in the county of Surrey and in the diocese of Rochester.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular part of the said new parish of Saint Mary (Prince's-road) Lambeth which is hereinafter mentioned and described should be constituted a separate district in manner hereinafter set forth.

"And whereas there is not at present within the limits of the said proposed district any consecrated church or chapel in use for the purpose

of Divine worship.

"And whereas we are satisfied that the said hereinbefore mentioned new parish is a cure wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof.

"And whereas certain hereditaments and premises situate within the limits of the said parish of Lambeth have become vested in us under the provisions of and for the purposes of the hereinbefore mentioned Acts or of some or one of them and we have in respect of such hereditaments and premises agreed to make and pay out of the common fund created by the firstly hereinbefore mentioned Act to the Minister of the district hereinafter recommended to be constituted so soon as a minister shall have been appointed and licensed in accordance with the provisions of the secondly hereinbefore mentioned Act and to his successors a grant of one hundred and fifty pounds per annum.

"And whereas such grant as aforesaid will be made by an instrument to be executed by us under our common seal in accordance with the provisions of the Act of the twenty-ninth and thirtieth years of Her said late Majesty chapter

one hundred and eleven.

"Now therefore with the consent of the Right Reverend Edward Stuart Bishop of the said diocese of Rochester (in testimony whereof he has signed and sealed this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that all that part of the said new parish of Saint Mary (Prince's-road) Lambeth which is described in the Schedule hereunder written all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of Saint Anselm Kennington Cross.'
