from a sanitary point of view which would be introduced into Austria-Hungary during the time that the present Decree is in force, will be sent to the nearest lazaretto at the expense of the parties and there will be subjected by the Authorities to destruction or to disinfection, according to the case, without taking into consideration the damage of the goods, and this will be done at the expense of the parties without granting any compensation.
