WHEREAS Orders (each of which is hereinafter referred to as a "Scheduled Order") have been issued by the Local Government Board to the

Guardians of the several Poor Law Unions named in the first column of the Schedule to this Order, bearing the dates placed opposite to the names of such Unions respectively in column 2 of that schedule; and by each scheduled Order regulations are prescribed with reference to the appointment of a Superintendent of the Casual Ward, and with reference to the salary and continuance in office of such Officer;

And whereas it is expedient that other provision be made with regard to the matters aforesaid:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order as follows:—

Notwithstanding anything in any scheduled Order, the provisions of the General Order made by the Poor Law Board, and dated the nineteenth day of August, one thousand eight hundred and sixty-seven, shall, upon any vacancy in the office of Superintendent of the Casual Ward of the Poor Law Union to which the scheduled Order relates, have effect with regard to every person who may be employed by the Guardians of that Poor Law Union to discharge the duties of the said office as if such person were a person employed under the said General Order, and so much of the Scheduled Order as may be inconsistent with the foregoing provision shall cease to have effect.
