ILE D'OUessant.

*Creac'h Light—Power Increased.*

WITH reference to Notice to Mariners No. 263 of 1901:—

The French Government has given further notice that, on 15th August 1901, the light power of Creac'h Point Light (white group flashing), Ile d'Ouessant, would be increased to from 15,000,000 to 30,000,000 candles, according to the state of the atmosphere, and the duration of each flash reduced to one-tenth of a second, but that in other respects the light remains unchanged.

Approximate position, lat 48° 28' N., long. 5° 8' W.
