THE following Despatches have been received by the Secretary of State for India from Lieutenant-General Sir Alfred Gaselee, G.C.I.E., K.C.B., Commanding the British Contingent, China Expeditionary Force:—

MY LORD, July 6, 1901.

NOW that I have received the orders of His Majesty's Government for the gradual reduction of the China Field Force, I submit, for your Lordship's information, what I presume will be my final Despatch as the General Officer Commanding the China Field Force.

2. In my Despatch No. 198 S, of the 17th January, I reviewed the events of last year, and brought to your Lordship's notice a number of Officers whom I considered worthy of commendation. In this, my final Despatch, it will therefore only be necessary to allude to what has since occurred, and to submit to your Lordship a further list of Officers who have done good service during the present year.

3. Military operations during this phase have, as far as the British troops are concerned, been confined to the repression of brigandage, the only operations of any importance being the affair near Funing, in which the late Major Browning lost his life, vide my Despatch, No. 4227 of the 5th May, in which I specially brought to notice the Officer commanding the column, Lieutenant-Colonel O. C. Radford, 4th Punjab Infantry.

4. The only other feature of the occupation worthy of note has been the transfer of the Peking-Shanhaikwan Railway from the Russian military authorities to German headquarters, and thence to the Railway Administration under the control of the British military authorities. I have fully described the history of this transfer in my Despatch No. 205 S, dated 23rd January, 1901, and my Despatch No. 337 S, dated 8th April, 1901, in which I dealt with the so-called Tientsin incident.

5. The troops have been mainly employed on detached duties, guarding the 250 miles of railway, and have performed these duties in a thoroughly satisfactory manner which reflects credit on all ranks.

6. I have now the honour to bring to your Lordship's notice the following Officers who have not been mentioned in my previous Despatches:—

In concluding this despatch, I venture, once more, to assure your Lordship of the excellent discipline maintained in the force throughout a long period of trying inaction, in the face of many demoralizing conditions, and some provocation. The Indian Army in China has not had great opportunities of adding to its laurels, but by its discipline, its fine soldierly appearance, and its thorough efficiency, I feel sure that its reputation has been largely enhanced in the eyes of our allies, while, at the same time, the loyal spirit and just pride of all ranks in themselves has been appreciably stimulated by their employment on a service of Imperial importance outside Indian limits.

6. No person shall swear or use obscene or offensive language whilst in or upon any carriage, or spit or commit any nuisance in or upon or against any carriage, or wilfully interfere with the comfort of any passenger.

7. No person shall wilfully damage or deface any portion of a carriage, or remove or deface any number plate, or advertisement notice, in or on the carriage. Any person acting in contravention of this Regulation shall be liable to the penalty prescribed by these Bye-laws and Regulations, in

addition to the liability to pay the amount of any damage done.

8. A person whose dress or clothing might, in the opinion of the conductor of a carriage, soil or injure the seats, linings, or cushions of the carriage, or the dress or clothing of any passenger, or a person who, in the opinion of the conductor, might for any other reason be offensive to passengers, shall not be entitled to enter or remain in or upon any carriage, and may be prevented from entering or remaining in or upon any carriage, and shall not enter any carriage, or be or remain in or upon any part thereof after having been requested not to do so by the conductor; and if found in or upon any carriage, shall, on request of the conductor, leave the carriage upon the fare, if previously paid, being returned.

9. Each passenger shall, upon demand, pay to the conductor, or other duly authorized officer of the Corporation, the fare legally demandable for the journey.

10. Each passenger shall show his ticket (if any), when required so to do, to the conductor or any duly authorized servant of the Corporation, and shall also, when required so to do, either deliver up his ticket or pay the fare legally demandable for the distance travelled over by such passenger.

11. A passenger, not being an artizan, mechanic, or daily labourer within the true intent and meaning of the Acts of Parliament relating to the Corporation, shall not use or attempt to use any ticket intended only for such artizans, mechanics, or daily labourers.

12. Personal or other luggage (including the tools of artizans, mechanics, and daily labourers) shall, unless otherwise permitted by the conductor, be placed on the front or driver's platform and not in the interior or on the roof of any carriage.

13. No passenger or other person, not being a servant of the Corporation, shall be permitted to travel on the steps of any carriage, or sit on the outside rail on the roof of any carriage, and shall cease to do so immediately on request by the conductor.

14. When any carriage is full inside, a notice to that effect, in conspicuous letters, shall be placed in a conspicuous position on the carriage, and no additional person shall enter such carriage.

15. When any carriage is full outside, a notice to that effect, in conspicuous letters, shall be placed in a conspicuous position, and no additional person shall mount on the outside of such carriage.

16. No person shall enter, mount, or leave, or attempt to enter, mount, or leave, any carriage whilst in motion.

17. No person shall enter, or mount, or attempt to enter or mount, any carriage arriving or standing at a terminus, or stopping place, until such passengers as may be upon the carriage, and as desire to dismount, shall have had a reasonable opportunity of doing so.
