to be adapted by the Company for working by electrical or other mechanical power are or will be situate by reducing the width of the footpath or otherwise.

(g) To use and dispose of any paving or road materials extracted by the Company in the construction of the intended tramways or the

exercise of the powers of the Bill.

(h) To purchase or acquire by agreement or to take easements over lands and houses for the purposes of the intended tramways and

works and of the Bill generally.

To authorise and empower the Company to enter upon take and use compulsorily or otherwise and to hold the lands hereinafter mentioned or some of them or some part or parts thereof respectively (that is to say):-

In the said Parish of Mitcham-

(a) A strip of land abutting on the north-west side of London-road Mitcham between points respectively situate 42 yards or thereabouts north-east and 133 yards or thereabouts south-west of Church-path.

(b) A strip of land 80 yards or thereabouts in length abutting on the east side of the main road from Mitcham to Sutton opposite

Mitcham Grove House.

In the said Parishes of Mitcham and Morden-Lands lying on both sides of the bridge carrying the main road from Mitcham to Sutton over the River Wandle near the Wandle Flour Mills and the bed and channel of the said river at and adjoining the said bridge.

In the Parish of Sutton.—(a) A strip of land abutting on the east side of the High-street Sutton extending for a distance of 34 yards or thereabouts south of Manor-lane.

(b) A strip of land abutting on the west side of the High-street Sutton extending from St. Nicholas-road for a distance of 89 yards or thereabouts in a northerly direction.

(c) A strip of land abutting on the east side of the said High-street Sutton extending for a distance of 70 yards or thereabouts southward from a point 3 yards or thereabouts south of the Police Station.

(d). A strip of land abutting on the south side of West Mead-road Sutton lying between William-road and St. Barnabas-road.

- In the Parish of Carshalton.—(a) A str p of land abutting on the north side of Westmead-road Carshalton and extending from opposite Ringstead-road for a distance of 193 yards or thereabouts in a westerly
- (b) A piece of land abutting on the west side of Ringstead-road at or about its junction with Westmead-road.
- (c) A piece of land abutting on the east side of Ringstead-road at or about its junction with Carshalton-road.
- (d) A strip of land abutting on the south side of Carshalton-road and extending from opposite Ringstead-road for a distance of 77 yards or thereabouts in an easterly direc-
- (e) A strip of land abutting on the north side of Carshalton-road extending from Highfieldroad for a distance of 83 yards or thereabouts westward.

(f) A strip of land abutting on the south side of Carshalton-road opposite Highfield-road.

- (g) A strip of land consisting of the forecourts of the houses on the south side of Carshalton-road immediately eastward of Cambridge-road.
- (h) A strip of land abutting on the south side of Carshalton-road and extending from a point 15 yards or theresbouts to a point

70 yards or thereabouts west of the Windsor Castle public house.

(i) Lands abutting on the north side of Carshalton-road at or about its junction with Pound-street.

(j) Lands abutting on the eastern and southernmost sides of Pound-street extending from Carshalton-road for a distance of

200 yards or thereabouts.

(k) A strip of land abutting on the northernmost side of Pound-street and extending from a point 25 yards or thereabouts to a point 153 yards or thereabouts north-eastward of the entrance gates to the Roman Catholic Convent.

(1) A strip of land abutting on the southernmost side of Pound-street Carshalton and extending from opposite West-street for a distance of 107 yards or thereabouts in a

north-easterly direction.

(m) Lands abutting on the north side of Pound-street and extending from the lane leading from Pound-street to Honeywood Walk for a distance of 200 yards or thereabouts in an easterly direction.

In the Parishes of Carshalton and Wallington (Hamlet).—Lands abutting on the south side of Acre-lane and the western side of Manorroad between Park-lane and the south side

of Wallington Green.

In the Parish of Wallington.—Lands abutting on the west side of Manor-road between Melbourne-road and the London Brighton and South Coast Railway.

In the Parish of Croydon.—(a) The property abutting on the north side of St. John's road and the west side of St. John's-grove at or about its junction with St. John's-grove.

(b) The property abutting on the westernmost side of Church-street near the junction

therewith of St. John's-grove.

(c) The property abutting on the southernmost side of Elis David-road at its junction with Church-street.

- (d) A strip of land abutting on the northernmost side of Elis David-road between the backs of the premises in Church-street and Ellis David-place.
- (e) The property abutting on the west side of Elis David-place for its entire length.
- (f) Property abutting on the west side of Tamworth-road at its junction with Lower Church-
- (g) Property abutting on the cast side of Tamworth-road and the south side of Waddon New-road at the junction of those roads.

(h) Property abutting on the east side of Pitlake Bridge at its northern end.

- (i) The forecourts of houses on the northernmost side of St. James'-road extending from a point 6 yards or thereabouts north-east ch Weilington-road for a distance of 57 yards or thereabouts measured north-eastward.
- (j) A strip of land a success on the southernmost side of St. James'-road between the junction therewith of Windmill-road and a point 120 yards or thereabouts south-westward thereof.

(k) A strip of land on the northernmost side of St. James'-road at or about the junction therewith of Lodge-road.

(l) A strip of land abutting on the east side of Whitehorse - lane between Whitworth-lane and South Norwood-hill.

(m) Lands abutting on the westernmost side of Whitehorse-lane and South Norwood-hill at or about the junction of those roads. (n) A strip of land on the westernmost side of
