And whereas the said scheme drawn up by the said Bishop is as follows:—

"The SCHEME.

"That the said chapelry of Greywell with the church thereto belonging shall be separated from the said parish of Odibam and constituted a separate parish and benefice for ecclesiastical purposes.

"That the parishioners of such chapelry shall be entitled to accommodation in the church situate therein but shall cease to be entitled to any accommodation in the parish church of Odiham except nevertheless any person or persons possessing a legal right by faculty or otherwise to any pew or sitting in the said church at Odiham and who may not be willing to relinquish and give up the same.

"That marriages baptisms churchings and burials shall be solemnized and performed in the church at Greywell for the inhabitants of the said District and all fees dues ecclesiastical offerings and emoluments arising from the said district shall henceforth belong to the Incumbent of the benefice of Greywell.

"That of the emoluments of the said benefice of Odiham there shall be transferred to Greywell the commuted tithe rent-charge of sixty-five pounds arising in respect of the said chapelry so as aforesaid to be separated from Odiham.

. "That the patronage of Greywell shall be vested in the Bishop of Winchester for the time being."

And whereas the said Bishop, as patron of the said benefice, has consented in writing to the said scheme, and the Reverend William Henry Windle, as Incumbent, has signed the consent following:—

"Consent of the Incumbent.
"I the Reverend William Henry Windle the present Incumbent of the benefice of Odiham with the chapelry of Greywell signify to your Grace my consent to the scheme above proposed and set forth and to every matter and thing therein contained.

"In testimony whereof I have hereunto set my hand this twenty-third day of September one thousand nine hundred and one.

William Henry Windle."

And whereas the said scheme hath been transmitted by the said Bishop to the said Archbishop for his consideration:

And whereas the said Archbishop being satisfied with the said scheme hath certified the same and the consents aforesaid to His Majesty in Council by his report dated the seventeenth day of October, one thousand nine hundred and one which said report is in the words and figures following:—

"We the undersigned Frederick, Archbishop of the Province of Canterbury, do hereby report to

Your Majesty in Council

"That the Right Reverend Randall Thomas Lord Bishop of Winchester has represented unto us (amongst other things)

"That there is in the county of Hants and his diocese of Winchester the vicarage of Odiham with the ancient chapelry of Greywell.

"That it appears to the said Lord Bishop that the said chapelry of Greywell may be advantageously separated from the said parish of Udiham and constituted a separate parish and benefice for ecclesiastical purposes only under the provisions of the Pluralities Act 1838.

"That pursuant to the directions contained in the said Act, the said Lord Bishop has drawn up a scheme in writing describing the mode in which it appears to him the proposed alteration may best be effected and how the changes consequent upon such alteration in respect to ecclesiastical jurisdic-

tion glebe lands tithes rent-charges and other ecclesiastical dues rates and payments and in respect to patronage and rights to pews may be made with justice to all parties interested which scheme together with the consents thereto in writing of the said Lord Bishop as the patron or person entitled to present in right of his Bishop-rick to the said benefice of Odiham with Greywell in case the same were now vacant and the Reverend William Henry Windle being the present Incumbent thereof has been transmitted to us by the said Lord Bishop for our consideration.

"The representation and scheme of the said Lord Bishop and the consents before referred to are hereunto annexed.

"And we the said Archbishop being on full consideration and enquiry satisfied with the said scheme do hereby pursuant to the said Pluralities Act 1838 certify the same and such consents as aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do make and issue an Order for carrying the said scheme into effect.

"As witness our hand this seventeenth day of October in the year of our Lord one thousand nine hundred and one. "F. Cantuar."

Now therefore His Majesty in Council by and with the advice of His suid Council is pleased to order as it is hereby ordered that the said scheme be carried into effect.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four; of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, duly prepared and laid before His Majesty in Council a scheme or representation, bearing date the twenty-fifth day of July, in the year one thousand nine hundred and one, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chapter ninety-four, of the Act of the thirteenth and fourteenth years of Her said late Majesty chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint John Dewsbury Moor of the new parish of the Holy Trinity Batley Carr of the new parish of West Town Dewsbury and of the new parish of Saint Mark: Dewsbury all in the county of York and in the diocese of Wakefield.

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the eleventh day of August in the year one thousand eight hundred and forty-two and published in the London Gazette on the twenty-fifth dayof October in the same year certain portions of the parish of Dewsbury in the said county of York
