and at that time in the diocese of Ripon (but now in the diocese of Wakefield a oresaid) were assigned as separate districts to the consecrated churches of Saint John Dewsbury Moor and of the Trinity Batley Carr and the same were called respectively 'The District Chapelry of Saint John Dewsbury Moor' and 'The Trinity Chapelry District Batley Carr.'

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the first day of May in the year one thousand eight hundred and forty-nine and published in the Loudon Gazette upon the fourth day of the same month a part of the said parish of Dewsbury (then in the said diocese of Ripo ) was assigned as a separate district to the consecrated church of Saint Matthew situate at West Town within the limits of the last-named parish and the same was called 'The Chapelry District of West Town Dewsbury.'

"And whereas the said district chapelry of Saint John Dewsbury Moor the said Trinity chapelry district of Batley Carr and the said chapelry district of West Town Dewsbury have each of them under the provisions of the Act of the nineteenth and twentieth years of Her said late Maj-sty chapter one hundred and four become a new parish of the character contemplated by that Act and by the Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four.

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the twenty-eighth day of December in the year one thousand eight hundred and sixty-six and published in the London Gazette on the first day of January in the year one thousand eight hundred and sixty-seven certain contiguous portions of the said I ew parish of the Holy Trinity Batley Carr (as the Trinity Chapelry District Batley Carr was then named) and of the parish of Wakefield aforesaid were assigned as a consolidated chapelry to the consecrated church of Saint Mark situate in the said new parish of the Holy Trinity Batley Carr and the same consolidated chapelry was called 'The Consolidated Chapelry of Saint Mark Dewsbury.

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the twenty-ninth day of February in the year one thousand eight hundred and sixty-eight and published in the London Gazette on the sixth day of March in the same year the boundaries of the said new parish of the Holy Trinity Batley Carr and of the said consolidated chapelry of Saint Mark Dewsbury were prospectively altered as upon and from the date of the then next avoidance in the incumbency of the said new parish of the Holy Trinity Batley Carr.

"And whereas such incumbency was avoided in the year one thousand eight hundred and ninetyseven.

"And whereas the said consolidated chapelry of Saint Mark Dewsbury has also under the provisions of the said Act of the nineteenth and twentieth years of Her said late Maj-sty chapter one hundred and four become a new parish of the character aforesaid.

"And whereas the said parish of Dewsbury and the cures hereinbefore mentioned became (inter alia) part of the said diocese of Wakefield on its foundation in the year one thousand eight hundred and eighty eight.

"And whereas it has been represented to us part of the s and it appears to us to be expedient that the Batley Carr.

boundaries of the said new parish of Saint John Dewsbury Moor of the said new parish of the Holy Trinity Batley Barr of the said new parish of West Town Dewsbury and of the said new parish of Saint Mark Dewsbury should be altered in the manner hereinafter mentioned.

"Now therefore with the consent of the Right Reverend George Rodney Bishop of the said diocese of Wakefield (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of Saint John Dewsbury Moor of the said new parish of the Holy Trinity Batley Carr of the said new parish of West Town Dewsbury and of the said new parish of Saint Mark Dewsbury shall be respectively altered so that all that portion of the said new parish of Saint Mark Dewsbury which is described in the First Schedule hereunder written and is delineate I and set forth upon the map or plan hereunto appended and is thereon coloured yellow shall be dissevered from such new parish and shall be restored to and shall in future again form part of the said parish of Dewsbury and that in like manner all that portion of the said parish of Dewsbury which is described in the second schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured green shall be annexed to and shall in future form part of the said new parish of West Town Dews-

"And that in like manner all that portion of the said new parish of Holy Trinity Batley Carr which is described in the third schedule hereunder written and is delineated and set forth upon the the said map or plan hereunto annexed and is thereon coloured brown shall be dissevered from the last-named new parish and shall be restored to and shall in future again form part of the said parish of Dewsbury.

"And that in like manner all those contiguous portions of the said parish of Dewsbury and of the new parish of the Holy Trinity Batley Carr aforesaid and also all that portion of the said new parish of Saint John Dewsbury Moor which are described in the Fourth Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon respectively coloured orange and violet and blue shall be annexed to and shall together in future form part of the said new parish of Saint Mark Dewsbury.

"And that in like manner all those portions of the said new parish of Saint Mark Dewsbury and of the new parish of the Holy Trinity Batley Carr which are described in the Fifth Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon respectively coloured red and grey shall be annexed to and shall together in future form part of the said new parish of Saint John Dewsbury Moor.

"And that in like manner all that portion of the parish of Batley in the said county of York and in the diocese of Wakefield aforesaid which is described in the Sixth Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured pink shall be annexed to and shall in future form part of the said new parish of the Holy Trinity-Batley Carr.
