"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or any of them or any other Act of Parliament.

"The SCHEDULES to which the foregoing Scheme or Representation has reference.

"THE FIRST SCHEDULE,

"The territory to be dissevered from the new parish of Saint Mark, Dewsbury, in the county of York, and in the diocese of Wakefield, and to be restored to the parish of Dewsbury in the said county and diocese being :-

"All that portion of the said new parish of Saint Mark, Dewsbury, which is bounded upon the south-west by the new parish of Saint John the Baptist, Daw Green, Dewsbury, in the said county and diocese upon the south and upon the south-east by the said parish of Dewsbury and upon the remaining sides, that is to sar, upon the north and upon the north-west by an imaginary line commencing upon the boundary which divides the said parish of Dewsbury from the new parish of Saint Mark, Dewsbury aforesaid, at the centre of the bridge which carries the Leeds, Dewsbury and Manchester line of the London and North Western Railway over Halifax-road and extending thence north-westward along the middle of the last-named road for a distance of four and a half chains or thereabouts to its junction with Spinkwell-road, and extending thence westward along the middle of the last-named road for a distance of two and a half chains or thereabouts to its junction with Willens-road and extending thence south-westward along the middle of the last-named road for a distance of nine and a half chains or thereabouts to its junction with Moorlands-road and extending thence first north-westward and then south-westward along the middle of the last-named road for a distance of thirteen chains or thereabouts to the boundary which divides the said new parish of Saint Mark, Dewsbury, from the new purish of Saint John the Baptist, Daw Green, Dewsbury aforesaid.

"THE SECOND SCHEDULE.

"The territory to be annexed to the new parish of West Town Dewsbury in the county

and diocese aforesaid being:-

"All that portion of the said parish of Dewsbury which is bounded upon the east, upon the south-east and upon the south-west by the new parish of Thornbill Lees in the county and diocese aforesaid upon the north-west by the said new parish of West Town Dewsbury and upon the remaining side, that is to say, upon the north-east by an imaginary line commencing upon the boundary which d vides the said new parish of West Town Dewsbury from the parish of Dewsbury aforesaid at the centre of the bridge which carries the said Leeds Dewsbury and Manchester line of the London and North Western Railway over Watergate-road and extending thence southeastward along the middle of the last-named road for a distance of five and a half chains or thereabouts to the south-eastern end of the same road on the western bank of the River Calder and continuing thence still south-eastward and in a straight line for a distance of one and a quarter chains or thereabouts to the boundary at the middle of the said River Calder which boundary divides the said parish of Dewsbury from the new parish of Thornbill Lees aforesaid.

"THE THIRD SCHEDULE.

parish of the Holy Triuity Batley Carr in the county and diocese aforesaid and to be restored to the parish of Dewsbury aforesaid, being:

" All that portion of the said new parish of the Holy Trinity Batley Carr which is bounded upon the south-east by the said parish of Dewsbury upon the east partly by the new parish of Saint Philip Dewsbury and partly by the new parish of Saint Paul Hanging Heaton both in the county and diocese aforesaid and upon the remaining sides that is to say upon the north and upon the west by an imaginary line commencing upon the boundary which divides the said new parish of Saint Paul Hanging Heaton from the new parish of the Holy Trinity Batley Carr aforesaid at the junction of Crackenedge-lane with the road which leads over the said Leeds Dewsbury and Manchester line of the London and North Western Railway aforesaid and over the line of the Dewsbury and Batley Branch of the Great Northern Railway into Bradford-road and extending thence northwestward along the middle of the last-named road for a distance of three and a half chains or thereabouts to the centre of the bridge which carries the said road over the Leeds Dewsbury and Manchester line of railway aforesaid and extending thence southward along the middle of the last-mentioned line of railway for a distance of sixteen chains or thereabouts to the boundary which divides the said new parish of the Holy Trinity Batley Carr from the parish of Dewsbury aforesaid.

" THE FOURTH SCHEDULE.

"The territory to be annexed to the said new parish of Saint Mark Dewsbury, being :-

"I. All those contiguous portions of the said parish of Dewsbury and of the new parish of the Holy Trinity Batley Carr aforesaid which taken together are bounded upon the west by the said new parish of Saint Mark Dewsbury and upon the remaining sides, that is to say, upon the southeast upon the east and upon the north by an imaginary line commencing upon the boundary which divides the said new parish of Saint Mark Dewsbury from the parish of Dewsbury aforesaid at the centre of the bridge which carries the said Leeds Dewsbury and Manchester line of the London and North Western Railway aforesaid over Bradford road and extending thence northeastward along the middle of the said line of railway for a distance of twenty-three and a half chains or thereabouts (thereby crossing the boundary which divides the said parish of Dewsbury from the new parish of the Holy Trinity Batley Carr aforesaid) to the centre of the said bridge which carries the said road leading from Crackenedge-lane into Bradford-road as aforesaid over the last-named line of railway and extending thence first westward then southward and then westward northward and westward along the the middle of the last-described road for a distance of nine chains or thereabouts to its junction with Bradford-road aforesaid upon the boundary which divides the said new parish of the Holy Trinity Batley Carr from the new parish of Saint Mark Dewsbury aforesaid.

"II. And also all that portion of the new parish of Saint John Dewsbury Moor in the county and diocese aforesaid which is bounded upon the north-east by the said new parish of Saint Mark Dewsbury and upon the remaining sides, that is to say, upon the north and upon the south-west by an imaginary line commencing at a point in the middle of Birkdale-road where the boundaries of the said new parish of Saint Mark Dewsbury of the new parish of the Haly Trinity "The territory to be dissevered from the new | Batley Carr aforesaid and of the said new parish
