

## No. 64.—UNITED STATES—ATLANTIC COAST.

*Delaware River Entrance—Wreck Removed,  
Buoy Withdrawn.*

WITH reference to Notice to Mariners No. 808 of 1901:—

The United States Government has given further notice, dated 11th January, 1902, that the wreck of the schooner ("Lavinia Campbell") which sank in the fairway, about half a mile N. 39° E. from Fourteen-foot Bank Lighthouse has been removed, and the light-buoy, painted in red and black horizontal bands, and exhibiting a white fixed light, moored with Brandywine Shoal Lighthouse bearing S. 30° E., distant 5 miles withdrawn.

Approximate position, lat. 39° 3½' N., long. 75° 10¾' W.

*Diamond Shoal Light-Vessel—Vertical Beam,  
Exhibition Postponed.*

The United States Government has given notice, dated 10th January, 1902, that the exhibition of a vertical beam of electric light from Diamond Shoal Light-vessel, moored about 14 miles south-eastward from Cape Hatteras has been postponed until further notice.
