10. Shorthand.

Candidates must pass to the satisfaction of the Civil Service Commissioners in the subject numbered 7, and must obtain such an aggregate number of marks as may indicate in the judgment of the Civil Service Commissioners a competent amount of general proficiency.

5. Persons holding situations in the Civil Service, Engineer Students in the Navy, and Apprentices in His Majesty's Dockyards, must obtain the written permission of the authorities of their Department to attend the Examination, dated before the commencement of the competition.

6. Application for permission to attend an Examination must be made in the writing of the Candidate, at such time and in such manner as may be fixed by the Commissioners.

7. A fee of £4 will be required from each Candidate attending these Examinations.
