KENT (FOOT-AND-MOUTH DISEASE) ORDER OF 1902 (No. 3).

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Alteration of Boundaries of Scheduled District.

1. The Scheduled District for the purposes of the Kent (Foot-and-Mouth Disease) Order of 1902 and the Kent (Foot-and-Mouth Disease) Order of 1902 (No. 2) shall after the commencement of this Order be the District described in the Schedule to this Order.

Commencement.

2. This Order shall come into operation on the twenty-second day of April, one thousand nine hundred and two.

Short Title, &c.

3. This Order may be cited as the KENT (FOOT-AND-MOUTH DISEASE) ORDER OF 1902 (No. 3), and shall be read with the Orders mentioned in Article 1 of this Order.
