**ORDER OF THE BOARD OF AGRICULTURE.**

(DATED 23RD MAY 1902.)

(SWINE-FEVER INFECTED AREA.)

The Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

*Extension of Limits of Swine-Fever Infected Area.*

1. The limits of the Swine-Fever Infected Area declared by Order of the Board dated the fifteenth day of January, one thousand nine hundred and two, are hereby extended so as to comprise the Area described in the Schedule to this Order, and the Area so described is hereby from and after the commencement of this Order declared to be an area infected with swine-fever for the purposes of the Swine-Fever (Infected Areas) Order of 1896.

*Commencement.*

2. This Order shall come into operation on the twenty-eighth day of May, one thousand nine hundred and two.
